The Birthday is a time spent remembering fallen comrades and focusing on a lot of memories, the good as well as the bad. It is a time when all Marines join for a day of celebration.

On November 11th, Americans celebrate Veteran's Day, while residents of Great Britain, Canada, and Australia

celebrate Remembrance Day. I have learned a few facts while researching Veteran's Day that I'd like to share with you:

According to the American Community Survey, there were 19.3 million military veterans in the United States in 2014. Of those, 1.6 million were female.

Veterans consist of people who serve in the military. This includes the Army, Navy, Marine Corps, Air Force, Coast Guard, and Active duty Guardsmen and reservist who served since 911. Veterans serve in times of war and peace.

The word "veteran" comes from the old English language and means "old, experienced soldier." The first use of the word was documented in 1789.

Upon retiring or being discharged, veterans may need help acclimating to life outside the military. The Department

of Veterans says about 30 percent of the Vietnam War veterans have been diagnosed with post traumatic stress disorder, or PTSD.

It was the Vietnam Veterans who led the way for our active duty soldiers today to get treatment for PTSD before being discharged and not have to wait 50 years like they did.

This last week my travels led me to Chester, IL to give a speech in the morning and across the state to Monticello, IL to give a speech before a parade. It is the only nighttime Veterans Day parade in the state of Illinois, and by the way, it was 42 degrees. My point is, we should be proud to be Americans and to take every opportunity to thank our veterans.

hat the vast majority of my articles over the years have dealt with what veterans should do. In this month's subject we will take a 180 degree turn and delve into what veterans should **NOT** do. There are always two sides to a coin.

If you are on the VA non-service connected pension program and someone asks you to collect their winnings from the horse races or gambling casino-**DON'T.** Regardless of their excuse (lost wallet, left driver's license at home, etc.) by collecting the winnings for them, the IRS will be notified under your Social Security number and name. Later when the VA and IRS computers run their cross matches you will end up with a large debt.

If you have a VA guaranteed mortgage **DON'T** let anyone assume the loan without first getting a release of liability. Without this release, if that person later defaults the VA will come back to you for any debt caused by foreclosure. A better course of action would be to get another vet to assume your loan. They can substitute their VA loan entitlement for yours and you are free and clear to use the Veterans Administration loan again.

DON'T just notify the VA hospital or clinic when you move. You must also notify the VA benefits side, especially if you have a claim or appeal pending. These two large VA computer systems don't yet talk to each other. So if you don't notify both parts of the VA you may get your medicine and appointment info at the new address but important information on your appeal may be returned by the Post Office as undeliverable. *PS: The Post Office will still forward mail for at least six months.*

If you file for any type of benefit **DON"T** wait months and even years and assume the VA will contact you when they get to your claim. Many claims fall through the cracks or are overlooked in the claims process. Check at least every two months to be sure it's on track. If you filed your income tax forms and were expecting a \$2,000 refund would you wait a year to contact the IRS?

Safe deposit boxes are nice places to keep important documents but **DON'T** keep your only copy of your military discharge papers in it. Have another copy somewhere at home so that when you pass away your next-of-kin will have access to it. Most bank vaults are not open on weekends, nights and holidays. In most cases the Funeral Home only needs a clear, readable copy, not the original.

If you use the VA hospital or clinic for some of your medical needs and also use outside doctors for certain other health concerns **DON'T** keep your VA primary care provider in the dark about your outside medications or testing. They have no way of knowing what you are prescribed by private physicians unless you tell them. And you don't want to have another colonoscopy if you just had one!

If you have been living with someone for years and you have agreed to take care of each other in sickness or health, that's wonderful. But **DON'T** think when you die that person will be eligible for survivors benefits. Illinois no longer recognizes common-law marriages. GET MARRIED.

Finally if you have been dating several months or having been living with someone for a while **DON'T** add them to your checking or savings account if your VA checks are on direct deposit. If you have a falling out or a lovers tiff that person can clean out your account and you have no recourse with the VA.

That was fun! And I'll leave you with one final tip; **DON'T** forget to read my article in next month's newsletter.

New Illinois License Plates^{*} Coming Soon

When the new year arrives, it'll bring with it a rollout of the new Illinois license plate redesign, Secretary of State Jesse White announced on November 15th.

The Capitol dome, the Chicago skyline and one-half of Abraham Lincoln's face will adorn new license plates.

The plate's new look, which White said will bring no additional cost for motorists, should stand up better to weather and use. Plates haven't been replaced on a large scale in some 15 years, and the old ones are getting rusty and losing reflectivity, which poses problems for law enforcement, according to White.

The redesign of Illinois' main license plate is the first since White's office unveiled the current look in 1999. That 1999 plate design -- consisting of a script "Illinois" above a Lincoln bust in the middle of the plate -- was chosen via an online vote open to Illinois residents.

No vote was held this time. Instead, the secretary of state's office "worked closely with law enforcement and developed a license plate that contains features unique to Illinois and is easy to read," said Henry Haupt, a secretary of state spokesman.

The resulting plate moves the Lincoln image to the left side of the design, getting it out of the way of the letters and numbers on the plate. It also contains white outlines of the Statehouse dome and Chicago's skyline, including the city's iconic Willis Tower.

"This is a forward-thinking, long-term solution that does not require a complete replating overhaul, which would cost around \$60 million," White said in a statement. "This plan removes older plates and replaces them with newly designed plates within our current budget. This will ensure that plates are appropriately replaced with the ultimate goal being no license plate on the road will be more than 10- years-old."

The staggered rollout begins next year, with replacement plates first going to motorists with the oldest plates, which were manufactured in 2000 and 2001; then plates from 2002 and 2003 will be replaced in 2018, etc. Vehicle owners will be contacted by mail when they qualify. The replacement of "B-Truck" plates, used on some pickup trucks, SUVs and vans, is expected to begin in 2018.

Motorists who are not due for a replacement may still request a new license plate in January at <u>cyberdriveillinois.com</u> for a replacement fee of \$29. In addition, vehicle owners with license plates manufactured after 2001 that are showing signs of wear and are difficult to read may visit <u>cyberdriveillinois.com</u> to apply for a newly designed plate at no charge.

Pearl Harbor's Legacy of Comebacks and Valor

President-Elect Trump has promised to rebuild our military so it can have the resources to better defend the United States. The American Legion supports all efforts that would strengthen our Armed Forces and we look to December 7th as a perfect example of why our nation must always be prepared.

Seventy-five years later most of the witnesses are no longer with us but the legacy of the men and women who defended Pearl Harbor on the day of infamy will always remain. It was a day that defined America and changed the world.

Service, sacrifice and valor were demonstrated by American

heroes at unprecedented levels and foreshadowed the trials, toughness and grit that epitomized the Greatest Generation during the Second World War.

Those who did not perish during the attack were not just veterans of battle. They were survivors of an unprovoked and unexpected massive killing spree.

Men like Sterling Cale, who would later serve his country in Korea and Vietnam after surviving numerous battles in the Pacific

War. A 20-year-old pharmacist mate assigned to the U.S. Naval Hospital Pearl Harbor on Dec. 7, 1941, Cale attended last year's American Legion Department of Hawaii observances of the attack.

Nearly three-quarters of a century later, he still recalled the charred bodies and ash that he recovered when he was put in charge of a burial party tasked with removing bodies from the USS Arizona.

"All black ash. One corpse didn't have a head," he said. These are the types of memories that continue to haunt even a battlehardened veteran that would later serve as a Navy corpsman with the 1st Marine Division at Guadalcanal.

Fellow survivor Bob Addobati founded the Pearl Harbor Survivors Association chapter in Sacramento, Calif. But it is December 6, 1941 that Addobati often remembered when he recalled the date of infamy.

"There was a battle of the band contest in Chinatown that night," he said in 2015. "All the ships had different bands. I spoke to several sailors from the USS Arizona's band. Eight hours later every sailor in that band was dead."

Like so many other survivors of Pearl Harbor, the attack was not the end for Mr. Addobati. It was the beginning for the

19-year-old signalman on the USS Solace. He would later lose his leg after his ship was torpedoed at the Admiralty Islands. He would raise a family, retire from the U.S. Postal Service and survive until January 15th of this year when, at the age of 93, he would reunite with his Fallen but never forgotten comrades.

So many are gone now. The more than 2,400 men, women and children who died from the attack would be joined by thousands of others in the seven and a half decades since. As those able to provide firsthand accounts leave the ranks of the

living, it is up to us to keep their legacies alive.

Fifteen Medals of Honor were awarded as a result of the attack. 51 Navy Crosses. 53 Silver Stars. Thousands of other acts of heroism were not recognized with medals because documenting the acts was not the priority. Saving others and fighting another day in order to defeat those who brought the war



became job one.

Sixty years after the attack on Pearl Harbor, America was caught off guard once again. September 11, 2001 was another date that will live in infamy to a new generation of Americans.

It would mark the beginning of another painful war – one against global terrorists that continues to this day. And while military members of the Greatest Generation took incredible risks to save their comrades, we saw similar courage from police officers, firefighters and first responders who entered burning buildings when logic and instinct would compel lesser people to move in the other direction.

Many of the 9/11 heroes were veterans. Nearly all were taught about the Pearl Harbor attack in history class. There was something very American about their response.

Just as the Pearl Harbor heroes were likely inspired by the doughboys of World War I, the valor that we continue to witness among today's military is at least partially the result of young men and women who want to live up to the legacies of those who preceded them.

Fearlessness is also the legacy of Pearl Harbor survivor Jack Evans. A 17-year-old lookout on the USS Tennessee during the (Pearl Harbor continued on page 13) The USS Illinois SSN-786 is a Virginia – class nuclearpowered fast attack submarine in service with the United States Navy. The USS ILLINOIS (SSN-786) is the 13th Virginia Class nuclear submarine.

The Virginia-class is designed for a broad spectrum of open-ocean and littoral missions. They are replacing older Los Angeles-class submarines, many of which have already been decommissioned. Virginia-class submarines will be acquired through 2043 and are expected to remain in service past2060.

Commissioning a new ship is a centuries-old tradition for our country and very much a civilian endeavor. It makes the completion of construction on a grand and complex scale and commits boat and crew to a 30 to 35 year mission of protection and projecting our national interest around the world.

There has not been a Navy ship named "Illinois" in over 100 years, since the battleship USS Illinois (BB7)

Displacing approximately 7,800 tons with a length of 370 feet, Virginia is longer but lighter than the previous Seawolf-class of submarines.

The 132-member crew can launch Tomahawk land-attack missiles from 12 vertical launch system tubes and Mark 48 advanced capability torpedoes from four 21-inch torpedo tubes.

Virginia will be able to attack targets ashore with

The Virginia class (or SSN-774 class) of attack submarines are the first U.S. subs to be designed for a broad spectrum of open-ocean and littoral missions around the world. They were designed as a cheaper alternative to the Cold War era Seawolf-class attack submarines, and are slated to replace aging Los Angeles class subs, seventeen of which have already been decommissioned.

WHEREAS,	Countless members of The American Legion died defending the Constitution of the United States and the First Amendment; and
WHEREAS,	The American Legion has fought bigotry, racism and similar concepts since its founding; and
WHEREAS,	The Preamble to the Constitution of The American Legion pledges that "For God and Country" we shall associate ourselves together "To foster and perpetuate a 100 percent Americanism"; and
WHEREAS,	There have been public displays of disrespect to the Flag of the United States, including during the National Anthem, by certain individuals, groups and others failing to show respect thereto; and
WHEREAS,	The American Legion realizes there are proper platforms for expressing protest or disagreement; and
WHEREAS,	The American Legion vehemently rejects using disrespect to the Flag of the United States or the National Anthem as a platform for publicly expressing protest or disagreement; now, therefore, be it
RESOLVED,	By the National Executive Committee of The American Legion in regular meeting assembled in Indianapolis, Indiana, on October 12-13, 2016, That The American Legion expects participants of all its programs to show proper respect to the Flag of the United States, at all times, including during the National Anthem; and, be it further
RESOLVED,	That the national organization of The American Legion recommends to departments and posts that the chairman or director of any American Legion program make clear to all participants in advance of the program that The American Legion has the expectation for rendering proper respect to the Flag of the United States, at all times, including during the National Anthem; and, be it further
RESOLVED,	That if any participant of any program of The American Legion cannot or will not live up to this expectation, the individual should not be a participant in American Legion programs; and, be it finally
RESOLVED,	That if any participant of any national-level program of The American Legion cannot or will not live up to this expectation, the individual will be removed from the program and not be allowed any further participation.

attack, his memory of that day was that, "Everything was on fire. Death and destruction everywhere." Yet the California native recently told The American Legion Magazine that he and his crewmates were not frightened.

"Most people just set their jawline and went about doing their jobs," he said. "There were very few who went into hysterics or anything of that nature. I really wasn't scared. It was so frustrating to be in a situation where there is so little you can do. You want to fight those guys and there was no way to do it."

Thankfully, they found a way. For Pearl Harbor is also the story of a remarkable comeback. The Japanese thought they would strike an early and crippling blow to America's Naval and Air capabilities. They failed.

Despite the advantage of surprise exploited by the Japanese planes and submarines, the feisty Americans at Pearl Harbor still destroyed 29 enemy aircraft, damaged 29 others and sunk or beached 5 mini-subs.

Six American battleships that were sunk or damaged during the attack, were restored, refloated and returned to service. Survivors who were physically able to continue their service, fought on for the duration of the war or until wounded or killed.

For the United States, Pearl Harbor marked the beginning of a war. For the Empire of Japan, it was the beginning of the end.
