Once again it's time to dispel some rumors that have been floating around out there. Thanks to those comrades who sent these to me to check out.

- 1. I'm going to be travelling to Germany this summer and I am 100% service-connected disabled. I don't have to worry about health coverage since I can stop into any military hospital. **FALSE**. Only active duty and some retired military can use that hospital system. However if you service-connected disabled condition acts up and you need emergency care that would probably be covered by the Veterans Administration but you would have to submit a claims form. This does not apply to treatment for non-service connected conditions. For example a veteran is service-connected disabled for diabetes and coronary artery disease. He or she is involved in a car accident and needs surgery. That would NOT be covered.
- 2. I have a claim pending now with the VA over a year. Since I am a member of the American Legion I want them to represent me on this issue and they <u>must</u> represent me. **MOSTLY FALSE.** If you have no power-of-attorney on file then we will be happy to assist you the best we can. However if you already have given your power-of-attorney to one of the other sister service organizations (DAV, VFW, AMVETS, etc.) then as a courtesy we will usually not allow you to switch. It would be like hiring a lawyer for a lawsuit. He then prepares the case, gathers the evidence, screens the jurors and is all ready for trial and you decide to get a new lawyer. Don't switch horses in midstream! Of course there are exceptions and our Department Service Officer can decide in unusual circumstances to allow a switch.
- 3. I just closed on a house six months ago and used my VA home loan guarantee benefits. I had to pay a "funding fee" at closing of over \$1,500. I was just awarded VA compensation benefits last week at the 20% rate for diabetes due to Agent Orange and I heard that I could get that "funding fee" returned to me? **TRUE.** If you are rated 10% service-connected disabled or more you do not have to pay the "funding fee" and can ask for a refund.
- 4. The recent tornados in Illinois went through part of our town cemetery and my grandfather's VA issued headstone was destroyed. It was placed there over 40 years ago and I was told I could get a replacement free. **TRUE**. The VA will always replace damaged, destroyed, worn or even stolen headstones and markers.
- 5. My spouse recently passed away and while she was alive we were getting an exemption on our property taxes here in Illinois. She was a service-connected disabled vet. I heard that I will lose that exemption now that she is gone. **FALSE**. As long as the surviving spouse doesn't remarry and continues to live in the property the property tax exemption passes on to them.
- 6. I was recently diagnosed with prostate cancer and they had to remove my prostate gland. The residuals of that surgery has affected my entire lifestyle and I find myself going through bouts of depression. Although I am getting VA benefits for the residuals of my prostate cancer (I was exposed to Agent Orange in Nam) I was told I can't get additional benefits for the depression since it didn't start while I was in service. **FALSE**. If your VA or private doctor opines that the depression is a direct result of your prostate condition the VA will grant you benefits for that depression as being secondary to the cancer.

That's all for now. Just came back from the Washington D.C. conference and our semi-annual Service Officer Training. Will have lots of good stuff in the next issue.





Illinois Senate Bill 87 and 1242

We have two bills pending in the Illinois Senate SB87 which corrects the standard homestead exemption for veterans with disability. The amendment would add the surviving spouse in the event the veteran dies before his claim is approved. Please have your members ask their Senator and Rep. for support.

The other bill SB 1242 will create a partnership between the IDVA and VAC by giving VAC's state accreditation. Currently Illinois is 10th in vet population, 16th in dollars coming back and 51st in avg compensation for disabled veterans. With the State and County working together we can do more outreach. VAC's are located in 47 counties and they work evenings and weekends. The Chicago regional office currently has 8,000 claims pending, 3,000 have no VSO representing them. Please support SB1242 and lets have the state and county together to better serve veterans and especially the surviving spouse. It will not cost the state a cent.

## Rendering Proper Respect

#### ATTENTION ALL POSTS

#### Important Notice

The American Legion is a strong supporter of the protection of the American Flag. The American Legion realizes there are proper platforms for expressing protest or disagreements. We vehemently reject using disrespect to the Flag of our Nation or the National Anthem as a way of protesting. The National Executive Committee passed the enclosed resolution addressing the issue for participants in our Youth programs.

Illinois strongly supports the action of The National Executive Committee. This means that local Posts will need to screen all participants in Boys State, Youth Police School, Oratorical Contest, American Legion Baseball or other programs to ensure compliance. Please take the time during the screening process to eliminate the embarrassment latter.

We support an individual's right to protest, but using our programs as a platform for that protest will not be allowed. Please ensure that whoever screens applications for participation in our Youth programs is aware of this new policy.

Resolution No. 16: Expectations for Rendering Proper Respect when Participating in Programs of The American Legion

Origin: Americanism Commission

**Submitted By: Americanism Commission** 

(As amended)

WHEREAS, The American Legion since its founding has supported this country, and

WHEREAS, Countless members of The American Legion died defending the Constitution of the United States and the First

Amendment; and

WHEREAS, The American Legion has fought bigotry, racism and similar concepts since its founding; and

WHEREAS, The Preamble to the Constitution of The American Legion pledges that "For God and Country" we shall associate ourselves

together "To foster and perpetuate a 100 percent Americanism"; and

WHEREAS, There have been public displays of disrespect to the Flag of the United States, including during the National Anthem, by

certain individuals, groups and others failing to show respect thereto; and

WHEREAS, The American Legion realizes there are proper platforms for expressing protest or disagreement; and

WHEREAS, The American Legion vehemently rejects using disrespect to the Flag of the United States or the National Anthem as a

platform for publicly expressing protest or disagreement; now, therefore, be it

RESOLVED, By the National Executive Committee of The American Legion in regular meeting assembled in Indianapolis, Indiana, on October 12-13, 2016, That The American Legion expects participants of all its programs to show proper

respect to the Flag of the United States, at all times, including during the National Anthem; and, be it further

RESOLVED, That the national organization of The American Legion recommends to departments and posts that the chairman or

director of any American Legion program make clear to all participants in advance of the program that The American Legion has the expectation for rendering proper respect to the Flag of the United States, at all times,

including during the National Anthem; and, be it further

RESOLVED, That if any participant of any program of The American Legion cannot or will not live up to this expectation, the

individual should not be a participant in American Legion programs; and, be it finally

RESOLVED, That if any participant of any national-level program of The American Legion cannot or will not live up to this

expectation, the individual will be removed from the program and not be allowed any further participation.

## **Special Olympics**

In June we help Special Olympics State Games over Father's Day Weekend in Normal, IL. The American Legion supports a Big Circus Hospitality tent for the athletes. We furnish shade, fruits, vegetables, cookies, and popsicles for 3,700 athletes, coaches, their families, and all the volunteers. We could always use extra people to pass out the food.

All our people are volunteers but they put in a big work day. On Friday night, the athletes have opening ceremonies just like the BIG OLYMPICS. The police have a torch run and the athletes march in, with their sponsors.


