



That as Chairman of the 1st Division VA&R committee I am required to make a report each year to that Division. I thought it would be informative to our members who live outside the 1st Division to see what we have accomplished up north. Part one was in the June newsletter, here is part two.

Our 1st Division website is a good place to find current information affecting veterans benefits and programs. Check it out at http://www.ilfirstdivision.org/. We have finally added a "tab" entitled Posts to Rent. You can get a drop down menu listing all the Posts and point-of-contacts for those who rent their halls.

Our Division hosted several District revitalization projects. They were very successful and helped our Division get many new transferred in members. We had a Service Officer at each one and as veterans had questions on their Veterans Administration benefits we assisted them. Several new claims were filed.

On March 11th 2017 we held our annual Service Officer Training class. We had over 100 attend and lots of valuable information was given out. Guest speakers included both the new Hines Hospital Director and the Chicago Regional Office Director. Three social workers from Hines also attended and gave us an inside view on what a Social Worker does. This information was well received.

By now most service-connected disabled veterans are aware of the great property tax reduction/exemption but if not here is what they receive:

Vets rated 30-40% \$2,500 reduction in assessed value

Vets rated 50-60% \$5,000 reduction in assessed value

Vets rate 70% or more NO PROPERTY TAXES!

If you were not aware of this you can contact your property tax office and ask for an amendment to your tax bill. This benefit in most respects passes on to the surviving spouse. As a current Veterans Administration letter will be needed each year veterans are encouraged to sign up for an eBenefits account so they can print out these letters right from home.

There were several major changes in Veterans Administration benefit laws. The first was regarding contaminated water at Camp Lejeune. Several types of cancer and Parkinson's disease can now be considered service-connected in most cases. There was a change in the Bronze Medallion for veterans who purchased headstones for private cemeteries. Veterans who died all the way back to World War I can now have their families order the Medallion. And finally veterans can now get official preauthorization to be buried in a Veterans Administration National Cemetery.

I continue to push our comrades to take advantage of both the eBenefits and the My healthevet websites. There are very useful tools and one can check their claims and appeals or e-mail questions to their doctor. The veterans scratch off lotto tickets are still being sold by the State of Illinois and your Department benefits in part from their sales.

I attended several town hall meetings at the VA Regional Office and Jesse Brown hospital. I made our presence known by wearing my cover and asked several pointed questions from the floor. I will continue to attend these events and ask others to come out and wear your blue hats.

The Cook County Recorder of Deeds has come out with a veterans discount card. This can be obtained at the downtown office of the Recorder or one of four suburban locations. This card entitles veterans to special discounts in participating businesses in Cook Co.

The Veterans Administration will be issuing a universal veteran ID card early next year (or so they say). Details will follow as they are made available.

In closing, I wish to thank outgoing Commander Whyte for letting me serve on this committee and as one of the Division Service Officers. I retired in 2005 which was when I decided to get really involved in the American Legion.


In 2006-2007 I was the 19th District Historian.

He has given numerous presentations at professional conferences. Mike is currently a Home Therapies Registered Nurse for Highland Park Fresenius Kidney Care, Highland Park, IL.

Mike enlisted in April 1967 for basic training at Ft. Leonard Wood, MO. Advanced Individual Training at Ft. Sam Houston, Texas, as medical corpsman. He had further training at Phoenixville General Hospital, Phoenixville, PA - Clinical Specialist School. In 1968 he was assigned to the 44th Medical Brigade Long Binh, Vietnam and then to 8th Field Hospital Nha Trang South Vietnam. Duties served as documents courier, medic and occasional personnel specialist. In 1969 reassigned to Ft. Knox, KY to the Adjutant Generals office. He was discharged from active duty in April 1969 and entered active reserves in the 410th Evac Hospital in Topeka, KS. Where he served as Wardmaster. He is currently Evanston Post 42 Historian, serving as Americanism Chairman for Post 42. 7th District and the 1st Division. He is also serving as Vice-Chairman of the Department of Illinois Americanism Commission and has served on the Commission for approximately 10 years. He is a member of the National Americanism council and National Legislative Council, 7th District Past Commanders Club (selected as Legionnaire of the year), 1st Division Past Commanders Club, ANAVICUS and Egyptian Past Commanders Club. He has completed The American Legion Extension Course.

Mike has one sister, Kathy Schmidt and 2 nephews. Both of his parents are deceased. Mike married Nancy Lee Trevena McGowan on November 21, 1990. Nancy passed away on August 20, 2015.

Veterans Complaint Line

The new White House Veterans Complaint Line went live on June 1st.

What will it do?

The phone line **855-948-2311** is designed to collect, process and respond to the complaints of individual Veterans in a responsive, timely and accountable manner according to Department of Veterans Affairs officials.

VA Secretary David Shulkin described the initial roll out of the line as a soft launch, with "live answer agents" receiving and processing some of the calls. Currently the hours of operation are from 8 a.m. to 5 p.m. EST, Monday thru Friday. He promised that by August 15th, the hotline will have continuous coverage from a live operator 24 hours a day, every day of the week.

If you have problems with the VA and feel it is not being handled through normal channels such as the Patient Advocate at Hines, Jesse Brown, Danville, Marion or the VA facility in the area you live call the hotline number and express your concerns or complaints.

Legion witnesses signing of VA accountability bill into law

American Legion National Commander Charles E. Schmidt, along with other National Headquarters staff, witnessed President Donald Trump sign **S. 1094**, the Department of Veterans Affairs (VA) Accountability and Whistleblower Protection Act of 2017, into law on June 23 during a special ceremony at the White House.

"The overwhelming majority of VA workers are truly dedicated to serving veterans in a professional manner. However, we know that this isn't always the case," Schmidt said. "All of us who served in the military understand accountability and that's what this new law is intended to deliver. The American Legion believes that you cannot fire your way to excellence, but the VA Secretary must have the ability to remove poor performers who are harming

an otherwise excellent veterans health care system. We appreciate the Trump administration's support in not just bringing accountability to the system but in protecting whistle-blowers who shed light on areas that need to be fixed."

The bipartisan legislation, which the House passed on June 13 following a 368-55 vote, will enhance accountability at the VA and provide

the department with the tools it needs to improve the care veterans receive. It is designed to:

- Increase VA's authority to remove employees at all levels of the department;
- Shorten the removal process and ensure an individual removed from the VA is not kept on the VA's payroll while appealing that decision; and also
- Make it easier for VA to remove poor performing senior executives and replace them with qualified candidates.

In addition, any appeals by senior VA executives would no longer be brought before the Merit Systems Protection Board, but instead would be handled directly by the VA secretary under an expedited timeline, according to the Senate Veterans Affairs Committee's (SVAC) website.

"This is one of the largest reforms to the VA in its history,"
Trump said. "VA accountability is essential to making sure that our veterans are treated with the respect they have so richly earned through their blood, sweat and tears. This law will finally give the VA secretary ... the authority to remove federal employees who fail and endanger our veterans — and to do so quickly and effectively."

As SVAC noted, **S. 1094** also includes a number of other provisions to hold employees accountable as it:

Requires VA to evaluate supervisors based on the protection of whistleblowers;

Incentivizes managers to address poor performance

and misconduct among employees by requiring the VA secretary to include this as part of the annual performance plan;

Prohibits bonuses for employees who have been found guilty of wrongdoing; and

Prohibits relocation expenses to employees who abuse the system.

"At the same time, this bill protects whistleblowers who do the right thing. We want to reward, cherish and promote the many dedicated employees at the VA," Trump said. "This legislation also gives the VA secretary the authority to appoint new medical directors at VA hospitals – something which was almost impossible to do in the past."

Trump said this is only the beginning and his administration will not rest until the job is 100 percent complete. This new legislation is about striving to better support and serve incredible veterans every single day, he said.

"We won't be able to accomplish any of the reforms that we need to have in the VA if we don't get the right people in place," said VA Secretary David Shulkin. "Veterans deserve a VA that they can trust and take pride in. VA is a national resource that must be protected in order to serve veterans and their families for generations to come."


WEARING OF THE AMERICAN LEGION CAP

According to Resolution No. 46, passed in spring 1965 by the National Executive Committee:

"A LEGIONNAIRE IS CONSIDERED TO BE IN UNIFORM IF WEARING AN OFFICIAL AMERICAN LEGION CAP."

The following text is from The American Legion Officer's Guide & Manual of Ceremonies, 2017, available for download at www.legion.org/publications

 The Legion cap, uniform, or regalia should be worn by its members only when in attendance at official Legion meetings or ceremonies, as official guests at patriotic or other civil functions, or by individuals when officially representing The American Legion on public occasions. For



all ceremonies, the uniforms adopted by a department are recommended. However, an official American Legion cap, dark blue or black civilian coat, dark trousers, white shirt, black four-in-hand tie, black shoes and socks make an attractive uniform. A Legionnaire is

considered to be in



uniform if
wearing an
official
American
Legion cap.
Therefore, it is
not proper to
wear a Legion
cap while
eating a meal
at an official
American Legion

or civic luncheon or dinner.

- The cap should be worn in a place of worship only by the guard of honor, color guard and commander of the same while in marching order or standing guard. When one is seated, the cap should be removed.
- 3. Posts marching in formation into a place of worship should uncover at the door, hold the cap with the right hand over the heart until arriving in the pews and commanded to take seats, and remain uncovered during the entire service. At the close of the service, upon command, the post shall rise, hold the cap with right hand over the hearts, march out of the place of worship, and recover after marching through the door. Note: The cap should be held over the heart as one approaches the casket, and is not at any time worn in a place of worship except by the guard of honor, color guard or commander of same while in marching order or standing guard.
- Legionnaires not in formation will uncover upon entering the place of worship, remain uncovered during the entire

service and re-cover after leaving the place of worship.

- At the graveside, the cap should be held in the right hand over the heart during the entire service. In cold and inclement weather, the cap should not be doffed.
- 6. In meetings, the cap should be worn except during the Pledge of Allegiance, prayer and while standing in silent reverence in memory of departed comrades, when it should be held with the right hand over the heart.
- 7. A Legionnaire wearing a cap should behave in proper accordance as to salutes, etc., the same as if wearing a military uniform. If not wearing a cap, observe ordinary rules of etiquette for civilian dress.
- 8. Female Legionnaires should wear their caps in the manner prescribed for women in the

armed forces. This is suitable for most situations, but taste and common sense should prevail. By



 Legionnaires wishing to attach decorations and/or other official insignia to their caps are advised of NEC Resolution No. 58, adopted April 30-May 1, 1964.

POST PROGRAMS & TRADEMARK PROTECTION

Protecting the American Legion Emblems

The following text is from "Name and Emblem Use and Protection Guide" available for download at www.legion.org/publications

In order to abide by federal trademark protection law and protect the most precious symbols of The American Legion — our more than 40 trademarked images and emblems — there are long-standing rules that apply to posts, post committees, post activities and sponsored programs including American Legion Baseball teams, American Legion Amateur

Radio clubs, Sons of The American Legion



squadrons and American Legion Riders chapters.

Background Years ago, a subsidiary corporation of a department attempted to gain control of an emblem of The American Legion through a state court action. The state court judge granted a temporary restraining order. Immediately upon issuance of the order and well before it expired, The American Legion filed a case in federal court, with the cooperation of the department, and put an end to the matter. The subsidiary was dissolved. This was all done in accordance with Resolution No. 11, adopted by the NEC on May 4-5, 2005.

Result Trademark law requires that The American Legion be certain that its name and emblem are used exclusively for those purposes determined by The American Legion. The American Legion has no choice or room to maneuver in this area of the law. However, we do know that once a court rules on a trademark matter, it's too late. One of the tests to show exclusive use and to protect the emblem is

"constant and continuous

control."

In this context, departments and posts may have subsidiary corporations or groups such as a trust or foundation if they so desire. The department, or post, needs to request the national adjutant's permission for the group to use the name and/or emblem of The American Legion. Moreover, because of the requirements of the trademark law, such subsidiary programs, trusts or foundations - including Sons of The American Legion and American Legion Riders must meet the following requirements:

1. All officers, directors, trustees, etc. must be named by the post (usually nominated by the membership but ultimately named and installed by the post). Sons squadrons, Riders chapters and similar activities are often granted the courtesy of holding elections for

program officers. These elections serve only as nominations. The officers must be named or installed by the post commander or general membership.

2. All vacancies in subsidiary programs must be filled (named) by the post. The post will name the replacement for any program chairman or officer unable to complete the term of appointment.


3. The subsidiary

- program officers must report to the post on program activities no less frequently than monthly. These reports must include financial reports. In months without activity, a "Nothing to Report" will serve.
- 4. The post treasurer or finance officer must be signatory on all accounts. These officers are responsible for annual tax reporting and other requirements and must have access to all accounts at all times.
- 5. All amendments to program articles of incorporation or by-laws must be approved by the post. SAL constitutions and bylaws, and ALR constitutions and bylaws or "standing rules" are not valid until approved by the sponsoring post.
