CHANGES TO TEMPORARY FINANCIAL ASSISTANCE PROGRAM

"Since its establishment in 1925, The American Legion Temporary Financial Assistance (TFA) program has awarded cash grants to minor children of current active duty or American Legion members. These grants help families in need meet the cost of shelter, food, utilities and health expenses, thereby keeping the child or children in a more stable environment."

The above is the core statement of the Temporary Financial Assistance program. However during the 2017 Fall National Executive Committee (NEC) Meetings changes to this program were made. Resolution No. 8 was submitted by the National Finance Committee regarding the restructuring of The American Legion Temporary Financial Assistance (TFA) program.

Due to steadily declining membership of The American Legion that adversely impacts operational program budgets, the restructure of the Statement of Policy under which the Temporary Financial Assistance program is administered was recommended by the Americanism Commission.

Resolution No. 8: Restructure of Temporary Financial Assistance Statement of Policy was approved. Below are the Resolved clauses. To read American Legion National Executive Committee Resolution No. 8 in it's entirety go to: https://archive.legion.org/handle/123456789/6966

RESOLVED, By the National Executive Committee of The American Legion in regular meeting assembled in Indianapolis, Indiana, on October 11-12, 2017, That the statement of policy governing the Temporary Financial Assistance hereby be restructured as follows for enhanced fiscal administration and efficiency of the program: • A single onetime non-repayable Temporary Financial Assistance grant of up to \$1,500 will be permitted in accordance with the conditions set forth in Exhibit A for the minor child(ren) of a qualifying veteran • A qualifying veteran is defined as a member of the United States Armed Forces serving on federal orders current under Title 10 of the United States Code, inclusive of all components, or any veteran possessing an up-to-date membership in The American Legion 2 • Formal documentation is required as part of the Temporary Financial Assistance investigation process and application packet for verification that all other forms of financial assistance available have been sought and applied for, or have already been denied • Annual cumulative expenditure of Temporary Financial Assistance grants may not exceed \$700,000 without prior approval of each chairman of the Americanism and Finance Commissions and the national commander; and, be it further

RESOLVED, That the statement of policy governing the Temporary Financial Assistance program found in Exhibit A incorporate the above new criteria and the following additions previously authorized by Resolution No. 38 of the National Executive Committee, May 2000, titled Addition to Temporary Financial Assistance Statement of Policy: e. A child (not included in 1(a-d) above) in custody of the veteran, or spouse of the veteran, living in the household of the veteran or surviving spouse, provided: (1) The veteran or spouse of the veteran is legally responsible for the child and has the legal right to exercise parental control and responsibility for the welfare and care of the child as stipulated by court order, or other legal documentation, transferring custody of the child to the veteran or spouse of the veteran, or f. A child in joint physical custody of a veteran and/or veteran's spouse, except that: (1) Resources of both households must be considered in determining the needs of the child, without regard to the present location of the child.

RESOLVED, That Exhibit A, updated as attached, be adopted in its entirety for governing the Temporary Financial Assistance program; and, be it finally

RESOLVED, That Resolution No. 27 of the National Executive Committee, May 1990, titled Statement of Policy Regarding Temporary Financial Assistance Program and Resolution No. 38 of the National Executive Committee, May 2000, titled Addition to Temporary Financial Assistance Statement of Policy are both hereby superseded and rescinded.

Did You Know?

That once again it is the start of a New Year and with that brings personal resolutions which we all seem to make (and most break or give up by February). Last January I listed most of these and got many good comments. But when I asked if they acted upon them most didn't! Here are those ideas tailor made for our Legionnaires. As a Service Officer if our comrades took these resolutions seriously my job would be so much easier.

- If you are enrolled in the VA hospital system then sign up for Myhealthevet. You can do this online at <u>http://www.va.gov/health/</u> and once signed up you can check your appointments, e-mail your doctors with medical questions, refill your pre-scriptions and a host of other things.
- 2. Check your property taxes. If you are a service-connected disabled vet rated 30% or more you should be receiving a reduction in your assessed value. If you are 70% or more you pay NO taxes if your home is valued under \$750,000. Be proactive too, if your spouse is NOT on the title then this exemption will not pass to them. While you're at it, be sure you are getting your senior discount if you are 65 or older. That law was changed and you must sign up each year for the senior break.
- 3. If you are 30% or more service connected disabled are you claiming all your dependents? Did you have another child or did you marry in 2017 and become a step-parent; or did your adult child who hasn't gone to school since they turned 18 sud-denly decide to enroll in college or a trade school? You can claim that adult child up to the age of 23 if they attend school (even part-time). And on the flip side did you divorce or lose a dependent due to a death this year? If so you need to noti-fy the VA to avoid and overpayment.
- 4. If you have VA life insurance or for that matter a commercial policy did you update your beneficiary due to a death, remarriage or divorce last year? Did your good for nothing adult child become a substance misuser? Do you really want to leave him or her your insurance now?
- 5. Due to a fire, flood, robbery or tornado did you lose your military discharge papers? If so contact me for standard form 180 to get a replacement. Believe me, sooner or later you will have to have a certified copy. 2017 was especially a horrible year for fires our west and hurricanes down south.
- 6. Are you being proactive and making arrangements for your demise? If you would like a free VA government headstone you might want to get the application ahead of time and fill it out. That way you will have exactly what you wish engraved on that marker. Call 1-800-827-1000 and ask for VA form 1330. And to save your next-of-kin the time and effort how about choosing an undertaker ahead of time.
- 7. Are you getting either VA compensation or pension benefits and have not yet signed up for Ebenefits? If not got to <u>https://www.ebenefits.va.gov/ebenefits-portal/ebenefits.portal</u> and do it today. Then from the privacy of your home computer (24/7) you can print out VA award letters, statements of service, home loan certificates and verification of your disability percentage. You can also check the status of your claim and/or appeals, review your last 24 months of payments and change your address or direct deposit information.
- 8. When was the last time you asked the VA to review your service-connected compensation. That bad knee you got in Vietnam probably has gotten worse in the last 40+ years. Or that busted shoulder blade from an explosion in Iraq is acting up. And that minor diabetic problem you got from Agent Orange may have become more severe and led to other complications. Very few medical conditions stay the same and most get more severe with the passage of time. Contact us today to discuss this further. THIS IS ESPECIALLY IMPORTANT WITH THE NEW PROPERTY TAX EXEMPTIONS.
- 9. Finally, resolve to sign up at least one new member for your post. Someone from your neighborhood, church or community group? Perhaps a friend or relative on active duty. Your post always needs your support in getting new members.

Well I hope some of these ideas are helpful. If you should need any further information on any of the above resolutions please contact me. Also, I've been collecting more rumors that are out there for a future article. If you have any let me know and I'll check them out. Until next time stay safe and warm.

Let our New Year's resolution be this: we will be there for one another as fellow members of The American Legion, in the finest sense of the word Comradeship.

Bipartisan support for legislation expanding caregiver benefits



The American Legion and several other veterans service organizations (VSOs) recently delivered more than 180,000 signed petitions to Congress that urges lawmakers to pass bipartisan legislation that will expand caregiver benefits for all disabled veterans under the Department of Veterans Affairs Comprehensive Caregiver Assistance Program. The bill, which the Senate Committee on Veterans' Affairs passed on Nov. 29 by a 14-1 vote, would help improve existing health care and services provided under the VA by expanding eligibility for veterans of all generations, including Vietnam-era servicemembers. It would also provide permanent, streamlined access to health care and services with a new Veterans Community Care Program.

The petitions were delivered during a press conference on Dec. 6 at the U.S. Capitol in Washington, D.C. VSO representatives spoke about the importance of ensuring equal benefits to veterans of all generations. House and Senate leaders, including sponsors of the <u>Caring for Our Veterans Act of 2017</u>, were also present to voice their support and celebrate the bill's passage last week in the Senate VA committee.

"Far too many veterans and their caregivers have been denied access to VA's comprehensive caregivers benefits for the wrong reason," said American Legion National Legislative Deputy Director Derek Fronabarger. "The American Legion believes eligibility for veterans' benefits should not be based on when a veteran served, but rather how they served and their physical and mental condition upon returning home."

"As the daughter of a World War II veteran who visits with veterans in my home state of Washington, I have seen firsthand the vital role that caregivers fulfill," said Sen. Patty Murray, D-Wash., a senior Senate VA committee member who is the bill's lead sponsor. "It is impossible to overstate the value of having a family member or a loved one, by your side, while overcoming an illness or coping with an injury.

"The sacrifice that many caregivers make to provide vital day-to-day care for our wounded veterans often goes unnoticed. Taking care of our veterans means taking care of the caregivers who help make their recovery possible."

Under VA's current Program of Comprehensive Assistance for Family Caregivers, only veterans who served on or after 9/11 are eligible for enhanced support. The Caring for Our Veterans Act seeks to provide caregiver benefits to veterans injured before May 7, 1975. Veterans who were injured between 1975 and 2001 would be eligible two years after this bill is enacted.

"We made a promise to care for our brave men and women when they return home from war – that includes supporting our caregivers," Murray said. "We cannot stop until we get this done."

Fronabarger said the nation should not and cannot treat veterans differently based only on their service. He said that withholding caregiver benefits of those who served before 9/11 is not giving them the respect and dignity they deserve.

"It is our hope to correct a serious flaw in the original caregiver legislation by removing the discriminatory barriers that prevent some of our nation's most deserving veterans, and their caregivers, from receiving the comprehensive assistance they have earned," he said. "The American Legion supports any responsible legislation that expands caregiver support to all veterans." "Caregivers are true partners in the delivery of health care to veterans and they deserve quality support," said Rep. Ryan Costello, R-Penn. "It is time that we expand this program to veterans of all generations."

The Caring for Our Veterans Act is now awaiting a vote in the full Senate. If passed, the bill would provide about \$4 billion for the Veterans Choice Fund and create standards for timely payment to community care providers.

"Often, caregivers put their lives on hold to provide full-time assistance to the veteran. This can take an immense toll on families, relationships, bank accounts and the health and well-being of caregivers," said Sen. Jon Tester, D-Mont., SVAC's ranking member who introduced the bill. "We cannot rest easy until our efforts to expand the VA's caregiver support program comes to fruition. Republicans, democrats and independents must continue to work together to get this legislation across the finish line and signed into law."
