Wayne Macejak, current Department Service Officer will be retiring November 1st. His replacement will be Carolina Contreras. Carolina is one of 2 other Service Officers in the Chicago office. Flu shots are now available at all VA hospitals. Shingle shots are also available. The success rate for the current shots is higher than previous shingle shots.

During routine blood work the HEP C test can be requested. Once tested no further testing is needed unless the veteran feels they may have again been exposed to the virus.

Restoring trust in the VA and the computerization updates are topics of discussion. Especially the future of DOD and VA systems working together. The VA is time pressured to finish many claims which can lead to errors in processing. The RAMP is in effect but individuals should be cautious in switching programs. A much quicker decision is made but it doesn't mean it will be a successful award of benefits.

Regarding the DC conference in 2019; we have budgeted \$3,000 and that will divided by as many Commission members that attend with a cap of \$1,500 each if only two are able to make it.

Having no further business, the meeting was adjourned at 11:00. The next meeting will be held in the spring, date to be announced.
