#### LEGION FAMILY CARAVAN

#### Prepares for a boost in Membership

This month the Department of Illinois American Legion Family will be traveling north to south, east to west for its annual membership caravan. With each stop you will hear inspiring messages, see hustle and bustle of membership cards being collected, awards presented, and have an opportunity to visit with your State and National leadership.

It was 22 years ago when the membership caravan began Past Dept. SVC Marty Conatser noticed the decline in membership after the holiday season, seeing membership never moving more than two percentage points during the month of January.

Today PNC Marty Conatser, says "during this time of year the caravan encourages our members to go out and work membership, get the renewals or sign up new members so they have something to turn in at their caravan stop." "Instead of a big winter lull, this gets us back to doing what we know we should have been doing all along, which is focusing on membership", says Conatser.

Every year since, to get membership back on the minds of Legion Family members, a caravan of 15 plus—National, Department, Auxiliary and Sons of The American Legion—members visit 19 posts in several districts over the course of nine days in January (17th through the 26th). Letters were mailed to all 733 post Commanders and Adjutants to notify their members of where and when the caravan will stop encouraging them to attend, and asking the posts, units, and squadrons to turn in membership cards they may have—even if it's just one! Last year, the caravan collected almost 1,000 legion membership cards.

Department Membership Director Chad Woodburn said, "Since I've been involved I find that the caravan is a great motivational tool for the entire legion family. It increases our membership during the winter season and encourages us all to actively get back to working membership.

"It also gives us a the opportunity to take a national representative to an individual post. Many posts say they've never had a national officer visit before. So it's a great honor that out of 733 Illinois posts, only 19 are selected. We are truly a family caravan and make it a point during our travels to express that 'We are an American Legion Family'." said Chad.

This year Past National Commander, Denise Rohan will be our special guest in the 2019 American Legion Family Membership caravan. If you haven't heard PNC Rohan speak before this is the time to hear her passionately speak on Legion issues, answer

questions, and promote 'Family First' as she did during her year as National Commander. You won't want to miss her inspiring message.

We will also be promoting our "4 Pillars -100 Years of Service" pin (pictured on the right). We will have pins and certificate on caravan for those who want to purchase this unique piece of history that gives back to four Illinois programs.

### From The Desk of Detachment Commander Eugene Gort



2018 was a good year for our Detachment. With the help of the American Legion, we were able to start 7 new squadrons last year. Hopefully

we can start a few more, and will be able to win the Hartline award at National Convention for the Detachment that starts the most squadrons.

That once again it is the start of a New Year and with that brings personal resolutions which we all seem to make (and most break or give up by February). Last January I listed most of these and got many great comments. But when I asked if they acted upon them most didn't! Here are those ideas again; tailor made for our

Legionnaires. As a Service Officer if our comrades took these resolutions seriously my job would be so much easier.

- 1. If you are enrolled in the VA hospital system then sign up for Myhealthevet. You can do this online at <a href="http://www.va.gov/health/">http://www.va.gov/health/</a> and once signed up you can check your appointments, e-mail your doctors with medical questions, refill your prescriptions and a host of other things.
- 2. Check your property taxes. If you are a service-connected disabled vet rated 30% or more you should be receiving a reduction in your assessed value. If you are 70% or more you pay NO taxes. Be proactive too, if your spouse is NOT on the title then this exemption will not pass to them. While you're at it, be sure you are getting your senior discount if you are 65 or older. That law was changed and you must sign up each year for the senior break.
- 3. If you are 30% or more service connected disabled are you claiming all your dependents? Did you have another child or did you marry in 2017 and become a step-parent; or did your adult child who hasn't gone to school since they turned 18 suddenly decide to enroll in college or a trade school? You can claim that adult child up to the age of 23 if they attend school (even part-time). And on the flip side did you divorce or lose a dependent due to a death this year? If so you need to notify the VA to avoid an overpayment.
- 4. If you have VA life insurance or for that matter a commercial policy did you update your beneficiary due to a death, remarriage or divorce last year? Did your good for nothing adult child become a substance misuser? Do you really want to leave him or her your insurance now?
- 5. Due to a fire, flood, robbery or tornado did you lose your military discharge papers? If so contact me for standard form 180 to get a replacement. Believe me, sooner or later you will have to have a certified copy. 2017 was especially a horrible year for fires and floods out west and hurricanes down south.
- 6. Are you being proactive and making arrangements for your demise? If you would like a free VA government headstone you might want to get the application ahead of time and fill it out. That way you will have exactly what you wish engraved on that marker. Call 1-800-827-1000 and ask for VA form 1330. And to save your next-of-kin the time and effort how about choosing an undertaker ahead of time.
- 7. Are you getting either VA compensation or pension benefits and have not yet signed up for Ebenefits? If not go to <a href="https://www.ebenefits.va.gov/ebenefits-portal/ebenefits.portal">https://www.ebenefits.va.gov/ebenefits-portal/ebenefits.portal</a> and do it today. Then from the privacy of your home computer (24/7) you can print out VA award letters, statements of service, home loan certificates and verification of your disability percentage. You can also check the status of your claim and/or appeals, review your last 24 months of payments and change your address or direct deposit information.
- 8. When was the last time you asked the VA to review your service-connected compensation. That dislocated shoulder you got in field training probably has gotten worse in the last 40+ years. Or that minor Bilateral Hearing Loss from an explosion in Iraq is worse and you now wear hearing aids. Or that minor diabetic problem you got from Agent Orange may have become more severe and led to other complications. Very few medical conditions stay the same and most get more severe with the passage of time. Contact us today to discuss this further. THIS IS ESPECIALLY IMPORTANT WITH THE NEW PROPERTY TAX EXEMPTIONS.
- 9. Finally, resolve to sign up at least one new member for your post. Someone from your neighborhood, church or communi ty group? Perhaps a friend or relative on active duty. Your post always needs your support in getting new members.

Well I hope some of these ideas are helpful. If you should need any further information on any of the above resolutions please contact me. Also, I've been collecting more rumors that are out there for a future article. If you have any let me know and I'll check them out. Until next time stay safe and warm.

Let our New Year's resolution be this: we will be there for one another as fellow members of The American Legion, in the finest sense of the word Comradeship.



# New membership retention incentives for posts and departments

American Legion National Commander Brett Reistad recently announced two new Team 100 incentives for American Legion posts and departments worldwide to collect financial rewards for returning members to their rosters, ramping up renewal rates and hitting their targets for 2019.

Posts will be awarded \$5 for every expired 2014, 2015, and 2016 member that rejoins the organization for 2019. And any American Legion department that achieve 100 percent of its 2019 membership target by May 8 will receive a \$2,500 reward. Departments that achieve 105 percent of its membership target by delegate strength date will receive an additional \$5,000.

Ads announcing these new membership rewards are available for posts and departments to use to spread the message to members. The Team 100 membership reward ads can be used in print for newsletters or flyers, Facebook posts and advertisement for websites.

## Spam emails on the rise



The American Legion National Headquarters IT Division is warning American Legion members to not immediately open attachments that come from what appear to be American Legion sources but may actually be spam.

There has been a recent in-

crease in spam email that appear to come from an American Legion source. If you receive an email from what you think is an American Legion account and it includes an attachment, consider the following before clicking on the attachment:

- The sender name is not quite right. Maybe it only has the last name, or the email address after the name is not @legion.org.

## More than 250 new laws go into effect in 2019

Illinois lawmakers completed the state's 100th General Assembly in its bicentennial year, and will ring in 2019 with 253 new laws on the books.

Some of the new laws imposed under outgoing Republican Gov. Bruce Rauner run the gamut from technical corrections in laws that will have little effect on people's daily lives to requiring parents of young children to keep them in rear-facing car seats longer, to blaze pink as acceptable for hunters' wardrobes, opioid abuse and school safety all will take center stage and a Route 66 centennial planning commission will convene.

An even busier year could be on the horizon in Springfield with Democratic Governor-elect J.B. Pritzker set to take over Jan. 14 and a legislative wish list that includes legalizing marijuana and sports betting.

Here's a sampling of Illinois' new laws for 2019.

- ★ MILITARY VETERANS Veterans and active duty military service members who are believed to have physical or mental health problems may now be considered "high risk" if they go missing.
- Health-care facilities will have to provide a free copy of a homeless veteran's medical records when requested by the veteran or an authorized agent for the purpose of supporting a veteran's claim for disability benefits.
- G.I. Bill of Rights Day Amends the State Commemorative Dates Act. Provides that the 4th day of November of each year is designated as "G.I. Bill of Rights Day", to be observed throughout the State as a day in recognition of the landmark legislation that provided benefits to World War II veterans, and would serve as the basis of future legislation to extend benefits to all who serve in the United States Armed Forces.
- Veterans-Members Benefit Fund Amends the Department of Veterans' Affairs Act. Provides that the Department of Veterans' Affairs
  may make expenditures from a members benefits fund, subject to approval by the Director of Veterans' Affairs, for recognition and
  appreciation programs for volunteers who assist the Veterans Homes.
- Veterans Home-Spouses— A non-veteran spouse shall have the same priority for admission to a Veterans Home as a veteran if they are admitted at the same time to live together.
- ★ FIREARMS A new law creates a 72-hour waiting period on all firearms, not just handguns.
  - Firearms restraining order: Allows family members or law enforcement to petition the court for an order alleging a person poses significant danger of causing personal injury to himself/herself or another by having in custody or control, owning, purchasing, possessing or receiving a firearm.
- **★ PUBLIC HEALTH & SAFETY**: Every school in Illinois must conduct at least one active-shooter safety drill administered by local police annually.
- Carnival operators must conduct criminal background checks on every ride operator they employ.
   Stalking laws will expand to include unwanted messages sent through social media apps.
- Missing persons with disabilities: Requires the Department of State Police to compile and maintain a data repository for missing persons with disabilities be considered a "high-risk missing person.
- Human trafficking notice requirements: Adds the following to the list of establishments required to post notice under the Human
  Trafficking Resource Center Notice Act: massage establishments; public gatherings and special events conducted on property open to
  the public that require the issuance of a permit from the unit of local government; public and private elementary and secondary
  schools; and establishments registered under the Tattoo and Body Piercing Establishment Registration Act.
- DCFS specialized placement trafficked youth: Provides that before July 1, 2019, the Department of Children and Family Services shall develop or enter contracts with agencies to provide specialized placements for youth who are victims of sex trafficking.
- Concussion information: Requires the Department of Public Health to develop, publish and disseminate a brochure to educate the public on the effects of concussions in children and how to look for warning signs. Requires schools to provide the brochure free of charge to parents/guardians of children who may have suffered a concussion regardless of where the concussion may have taken place.
- ★ OPIOID EPIDEMIC Those with licenses to prescribe opioids must complete three hours of continuing education on safe opioid-use practices before renewing their prescription licenses.
- Another law bars insurance and managed-care companies from requiring prior notification for specified in- or outpatient substanceabuse treatment in order to get those with drug-use disorders the help they need quickly.
- The state's Division of Alcoholism and Substance Abuse, part of the Department of Human Services, will be renamed the Division of Substance Use Prevention and Recovery, and the law governing it will be rewritten to better reflect the priority given to the opioidabuse epidemic. The aim is to provide clearer guidelines for medical and community-based organizations that provide intervention and treatment, and for insurance companies to adopt a standardized approach to such care.
- Medication disposal: Broadens the definition of "unused medication" to include medications that are in liquid form. This would permit
  police officers and nurses to dispose of liquid medications that are located at death scenes.

#### Registration open for 2019 American Legion Baseball season

Returning coaches may renew their teams or register new teams. New coaches should contact their department's chairman to find out more information about state-specific rules and deadlines.

Registration will run through the early deadline on May 15. Teams registered after May 15 will be subject to \$200 late fee through the final deadline on June 1.

Each state may set an earlier deadline for registration, however.

Teams registering in 2019 will spend the same amount in national fees and administrative fees as they did last season, while only spending \$6 more for insurance.

Fees for senior teams will remain \$50 for national registration, \$35 for administrative fees and either \$155 for season personal accident or \$225 for year-round coverage. General liability costs increased by \$6 to \$106.



Fees for junior teams will remain \$25 for national registration, \$35 for administrative fees and either \$130 for season personal accident or \$185 for year-round coverage. General liability costs increased by \$6 to \$74. State fees, if applicable, will vary by state.

#### **★** MISC.:

- Golden parachutes: Sets severance pay conditions for government employees in an attempt to prevent "golden parachutes." States that severance pay cannot exceed more than 20 weeks, so compensation and severance pay must be prohibited when the employee has been fired for misconduct. Introduced in response to recent situations where severance packages have cost taxpayers millions of dollars.
- Police can take temporary custody of dogs or cats exposed to weather conditions likely to result in injury or death.
- If you are required to use your personal phone or computer for work, your boss must have a reimbursement policy.

# NEW IN 2019: VA's Health Care Rules will be Completely Rewritten this Year

WASHINGTON — President Donald Trump has been promising expanded health care choices for veterans dating back to his election campaign in 2015. But 2019 could be the year his administration actually makes that happen.

Veterans Affairs has been working on expanded community care rules for veterans' medical appointments since last summer, when Congress approved the VA Mission Act. Details of that work are expected to be released in early 2019, and a full set of new regulations is scheduled to be released in early spring.

Among other priorities, the legislation mandated a retooling of the department's policies for veterans seeking private-sector care, a massive undertaking that supporters have hailed as giving more flexibility and freedom to veterans who face long lines at VA hospitals and clinics.

VA Secretary Robert Wilkie in December hailed the work as part of "a real transformational period at the department." But critics have attacked the work as the first step toward privatizing key parts of the VA mission.

Democrats, including House members who will be taking control of the chamber this year, have promised intense oversight into the new outside care rules, to ensure they aren't written to siphon off needed federal resources to private businesses.

As written, the legislation requires VA to remain a core coordinator of veterans health care plans but also to ensure "the scheduling of medical appointments in a timely manner," "continuity of care and services," and "no lapse in health care services."

That leaves a significant amount of work to be settled in the details of VA's implementation plan.

Currently, the VA's Choice program — the best known and most used of the community care programs — is restricted to veterans who live more than 40 miles from a VA facility or face a wait of more than 30 days for VA services.

The new programs will likely jettison those rules in favor of a looser set of guidelines, including language for veterans who face "an unusual or excessive burden" getting their care at VA facilities.

Veterans groups have advocated for more flexibility for care options but also warned against abandoning the current Veterans Health Administration, a key safety net for millions of veterans across the country.

A congressional hearing previewing the Mission Act implementation work was scheduled for early December but was postponed due to the death of former President George H.W. Bush. That has only added more mystery and urgency to the drafts under consideration by top VA officials.

#### A Rolling Shrine to Our long History

American Legion National Commander Brett Reistad wore a smile while waving to the crowd for the entire 5.5 miles, two-hour ride on the Legion Family's Tournament of Roses Parade float. And after almost an hour had passed since Reistad stepped off the float, the same smile remained.

The experience stayed with, and likely will stay with, the national commander.

"It was a rush. It was a big rush," Reis-

tad said. "It was exciting. You couldn't have had a better, more supportive crowd out there. It was like a parade that had no ending. It was just a phenomenal experience. I don't think that there's anything that I've ever done that compares to this level of excitement."

The parade had an estimated 700,000 people watching in person, while another 4 million were expected to tune in on either ABC, NBC, Hallmark Channel, Univision, RFD-TV or KTLA. "I really think it gave us some fantastic exposure," Reistad said. "People were very supportive as we passed. A lot of 'God bless the USA' and 'thank you for your service.' And they never stopped. The crowds just went on and on and on.

"And there were Legion Family members along the way that were very supporting, yelling out their post numbers. It was really great."

The American Legion float carried the message of "Still Serving America," highlighting every section of the Legion Family and its various youth programs. All of those components tied into the float's celebrating of The American Legion's centennial being celebrated this year.

"I don't think there was a better time to do this," Reistad said. "(Having) the goodwill of being out there, and people refreshing their knowledge and understanding of what The American Legion is, knowing we're out there still doing our good work."

The float's riders arrived at their spot in the lineup at around 6 a.m. It didn't take long for those walking up and down Orange Grove Boulevard to stop to thank those on the float and grab a photo op with one or all of the four Medal of Honor recipients riding along the Legion's float.

Once the parade began, those lining Orange Grove, Colorado Boulevard, Sierra Madre Boulevard and Villa Street – most areas along the route jam packed with parade watchers three, four and five persons deep – greeted those on the float with cries of "thank you," applause, salutes and often standing ovations.

Those reactions moved Walter "Joe" Marm – who joined fellow Medal of Honor recipients Hershel "Woody" Williams, Ron Rosser and Britt Slabinski on the float. "It's very humbling," Marm said. "We're in the greatest country in the world. It's just an honor to be here representing some of the veterans of our country. It's very special."

Marm said before that he felt honored to be in the parade. That opinion didn't change after the parade. "It was very, very special," he said. "The crowds were tremendous. It was just an honor to be here."



Cristina Molina, a member of Holly-wood Auxiliary Unit 43 and an American Legion Rider, also felt moved by the response from parade watchers, for a very special reason.

"It reminds me of my dad, my dad's service to this country and how proud I am of what he did," Molina said. "It makes me feel proud to be an American because veterans sacrifice a lot. They go and they serve to protect this country, and to hear people

acknowledge that, especially the little kids, it's amazing."

Sharing the float with Marm and the other Medal of Honor recipients also made an impact on Molina. "It was a once-in-a-lifetime experience. It was amazing. Humbling. You look around and you're on there with four Medal of Honor recipients. It's surreal. I couldn't believe it the whole time."

U.S. Air Force Airman First Class Kathleen Clingerman, one of a handful of active-duty military personnel on the float, said she was proud to represent her branch of service. The experience on the float itself "was overwhelming, I guess, for just the appreciation that people have for the service," she said.

For Sons of The American Legion National Adjutant Anthony Wright, the opportunity to ride on the float was "very eye-opening. The experience was great because I felt as a member of the Sons of The American Legion I was honoring my grandfather's and my father's service."

Wright was happy to see the Legion Family featured as prominently as it was on the float. "The American Legion Family is that: a family," he said. "To have The American Legion, The American Legion Auxiliary, the Sons of The American Legion and the American Legion Riders shows unity and that we're one group."

American Legion Past National Commander Dan Dellinger came to California last week to help with decorating the float. Seeing it go from a bare frame to fully decorated and passing along the parade route while he watched from the viewing stands was a memorable experience.

"I was sitting across the aisle (in the stands) from a two-star Marine general, and he stood up and clapped (when the float passed)," Dellinger said. "I thought that was very apropos for our float. Everyone in the stands gave a warm welcome to us. That made me feel really good."

Dellinger believes having a float in the 130th running of what is one of the world's most well-known parades made a positive impact on the

nation's view of The American Legion.

"I think it was a great step forward," he said. "I think there was a lot of pride across the country. I think people around this country saw us at our best. One hundred years of service to America, and we're going to continue to do so."
