Gold Star and Veterans Day at the Springfield State Fair is August 10, 2025. The DuQuoin State Fair runs from Aug 26-Sep 5, 2025, so it is suspected Veterans Day at the DuQuoin Fair will be Sunday Aug 31, 2025. At the Fair in Springfield, Veterans and their immediate families are admitted to the fair grounds free. A Veterans Parade and activities are some highlights. Discounted ride passes for families of the military veteran will be available in Springfield.

The veteran activities and events at the Springfield Fair are suggested by the Illinois Veterans Day State Fair Committee, a 501(c)(3) organization. The purpose of the committee is to publicize the Illinois State Fair Veterans Day program throughout the state, attend and actively participate during the day of activities at the fairgrounds, and to fund raise for the day's events. The committee's monthly meeting is held at the offices of the Illinois Department of Veterans Affairs (IDVA) in Springfield, with a virtual option available.

A discussion on the parade at the fair took place. In the past, the various veteran service organizations would provide a color guard and lead the parade at the fairgrounds, rotating the lead organization each year. In 2024, the VFW provided the color guard and led the parade. The determination as to who will lead the parade in 2025 has not been made as yet. Also discussed was parade entry registration. The form was apparently send to the department and the committee wasn't notified. Registration forms need to be send out several months prior to the parade to allow for anyone wishing to join in, to make their wishes known.

To raise funds for supporting the activities for the Veterans Day at the State Fair, a fund raising letter was developed to request sponsorship and donations from businesses.

Chairman Miller pointed out the description of the tasking for the State Fair Veterans Day and Uniformed Groups Committee is in the Department Directory. He pointed out that the duties of the committee are to help on Veterans Day at the fair and duties are assigned by the superintendent of the fair. The fair no longer has a superintendent, but now a Fair Manager. However, the organizing committee asks for volunteers to pass out the state fair pins and food vouchers, and other activities as needed.

The budget for the State Fair Committee remains the same as last year and the year before that at \$3,150. About the only expenditures that came from the 2023-2024 budget was travel. The American Legion did not provide any money for the JROTC awards in the past several years. In the past, different veteran service organizations would rotate funding the JrROTC 1st, 2nd and 3rd place plaques. That practice ceased 2022, with the awards presented to the winners bearing the names of the

supporting veterans service organizations.

Another duty of the Department State Fair committee is to promote the organization, maintenance and sponsorship of the various types of musical and drill groups in the Post, Districts or County Councils and arrange for competitions to conform to the rules of the National and Department Convention. We need to query within their division to determine if there were any color guard units active in their divisions. If so, then we could move forward and attempt to make arrangements for competition at the Department Convention.

Commander Lampert and Adjutant Conatser needed to leave for Indianapolis, so briefed Chairman Miller on some items to share with the committee.

First, Commander Lampert thanks the committees for their dedication and involvement, and as the first line in communicating to the legionnaires in the Posts, districts, and divisions. The communications regarding what is transpiring in the organization in relationship to activities begins at the commission/committee level. Share the information within posts, districts, and divisions; so that Legionnaires and the public can see what the Legion is doing. Let's not keep the Legion our best kept secret. Rather than just reporting what happens in the commission/committee meetings, share a bit about the programs the commissions/committees support and be the advocate for those programs.

Ensure your contact information is up to date in MyLegion.

Commissions and committee chairs must make an end of year report for inclusion in the convention book. Start making notes now.

Adjutant Conatser commented on the Department gun raffle. The last of the mailings have gone out through the hard work of Legion volunteers. Using in house volunteers helps save the department several thousands of dollars, over using an outside vendor to run the raffle.

Attached to these minutes are legislative actions that were introduced in the 103rd General Assembly. Miller spoke briefly about the status of these actions. Several were passed and became public acts, many others remain assigned to committees, with potentially no action in sight before the end of the 103rd General Assembly on January 5, 2025. The 104th General Assembly begins on January 6, 2025. Any legislation from the current assembly that needs to be re-introduced to the 104th, will need to be identified and sponsors acquired. The next time the General Assembly will meet will be for two weeks in November when they come together for

Legislative news and legislation to watch.

The Illinois 103rd General Assembly will end in January 2025 when the 104th General Assembly begins on January 6, 2025.

The House and Senate have been out and haven't had any meetings recently. The next time they will be in session is during the Veto Sessions in November. Veto session is held for six days every fall to allow the General Assembly to take action on bills that the governor has vetoed. Since the governor hasn't vetoed any bills in the 2nd session of the 104rd GA, we need to keep in mind the veto session is not limited to bills that have been vetoed, meaning almost anything could be called over the upcoming veto session.

Discussion regarding submission of witness slips. Whenever legislation is discussed in committee meetings, citizens are able to submit witness slips identifying their position on the legislation, whether they are a proponent or opponent on the subject legislation. The ILGA Dashboard may be found at https://my.ilga.gov . This dashboard shows the General Assembly session schedules. when committee meetings are scheduled, users may submit a witness slip.

In March of 2024, several veterans organizations visited capitol hill in Springfield to meet with legislators. Those present gathered in three groups representing northern Illinois, central Illinois, and southern Illinois to visit senators and representatives from their areas. It was generally considered successful and created a presence in the capital office buildings of the various organizations head covers. The plan is to conduct another Veterans Lobby Day on March 12, 2025.

A question came up about the appropriations for the PACT act.

There was a brief discussion regarding county Veterans Assistance Commissions (VAC), and informatin provided for information.

At 10:25, the neeting was visited by Department Commander, Joe Lampert; Department Sr Vice, Roy Smith; and Department Adjutant, Josh Thielen.

Commander Lampert encouraged communication at all levels, up and down. We owe it to legion members to let them know what is going on.

Sr Vice Smith spoke on membership. As of the date of the meeting, Illinois was in 14th place in the nation for membership. Need to conduct or keep conducting Buddy Checks, part of the communications process.

Adjutant Thielen addressed the need for members to keep their MyLegion information up to date. He also encouraged commission and committees to keep their portion of the web site up to date. All commission and committee chairmen should be turning in an End of Year report prior to the convention for inclusion in the convention book.

With no further business to conduct, the meeting ended at 10:35am. The next meeting will be held via Zoom, date to be announced.

Legislation considered during the 103rd General Assembly that became public law or resolutions that were adopted:

HB0612 - REVENUE-TECH Rep Kifowit *Public Act 103-0596, 7/1/24*

Replaces everything after the enacting clause. Amends the Property Tax Code. In a Section granting a homestead exemption to veterans with disabilities, provides that property that is used as a qualified residence by a veteran who was a member of the United States Armed Forces during World War II is exempt from taxation regardless of the veteran's level of disability. Provides that a veteran who qualifies as a result of his or her service in World War II need not reapply for the exemption. Makes changes concerning service-connected disabilities. Makes changes concerning surviving spouses.

HB4661 - PUBLIC UTILITIES-INFASTRUCTURE *Public Act 103-0679*, 7/19/24

Amends the Public Utilities Act. Provides that no electric utility shall establish or maintain any unreasonable difference as to rates or other charges, services, contractual terms, or facilities for access to or the use of its utility infrastructure by another person or for any other purpose. Amends the Electric Service Customer Choice and Rate Relief Law of 1997. Prohibits an electric utility in a county with a population of 3,000,000 or more from authorizing any other person or granting any other person the right, by agreement, lease, license, or otherwise, to access, control, use, or operate any electric utility's infrastructure, facilities, or assets of any kind or to deliver or provide to the electric utility's retail customers or any other person's customers, broadband services, Voice over Internet Protocol (VoIP) services, telecommunications services, or cable or video programming services. Specifies, however, that an electric utility in a county with a population of 3,000,000 or more may authorize or grant another person the right to access or use the electric utility's infrastructure, facilities, or assets, including, but not limited to, middle mile infrastructure, to facilitate the delivery of broadband services to Illinois residential and commercial customers on the condition that the access to and use of that electric utility's infrastructure, facilities, and assets (A) be granted on a non-discriminatory, nonexclusive, and competitively neutral basis; and (B) comply with all other State and federal laws, rules, and regulations, including, but not limited to, all applicable safety codes and requirements. Provides that, if there is any dispute regarding the terms, rates, or conditions of access to or use of the electric utility's infrastructure, facilities, and assets to facilitate the delivery of broadband services to Illinois residential and commercial customers, then the Commission shall hear and decide the dispute upon petition of any party. Provides that nothing in the amendatory Act shall be construed to alter or diminish the rights or obligations of any person nor shall it be deemed to conflict with the federal Pole Attachment Act. Specifies that these prohibitions become inoperative after December 31, 2027. Defines terms.

HB4757 - VETS-BENEFITS NOTICE POSTER Public Act 103-0828, 8/9/24

Amends the Department of Veterans' Affairs Act. Provides that the Department of Veterans Affairs shall create, and the Department of Labor shall make available, at no cost, a veterans and service members' benefits, services, and protections poster. Requires the poster to include, but not be limited to,

information regarding free veterans' benefits and services provided by the Illinois Department of Veterans Affairs and other veterans service organizations, tax benefits, the Illinois veteran driver's license and non-driver veteran identification card, and Illinois protections for survivors of sexual violence in the military. Requires the poster to also include contact information for the United States Department of Veterans Affairs, the Illinois Department of Veterans Affairs; and the Veterans Crisis Line. Effective January 1, 2025.

HB5640 - VETERANS-SPACE FORCE Became Public Act 103-0746, 8/2/24

Amends the Statute on Statutes. Provides that whenever there is a reference in any Act to "armed forces", "armed forces", "armed forces", "U.S. Armed Forces", "United States Armed Forces", or "uniformed services", these terms shall be construed to include the United States Space Force. Amends the Flag Display Act, the Secretary of State Merit Employment Code, the Veterans Preference Act, the Veterans Burial Places Act, and various other Acts. In all occurrences of the definition for "armed forces of the United States" and "member of the Armed Services or Reserve Forces of the United States" expands the list of armed forces branches to include the Space Force. Makes conforming changes in the definition of "veteran" under the Department of Commerce and Economic Opportunity Law, in the definition of "military service" under the Illinois Pension Code, and in a provision under the Veterans Burial Places Act that lists the various military branches that make up the Reserve Officers Training Corps. Makes other conforming changes.

HB5655 -VETERANS' SERVICES TASK FORCE Became Public Act 103-0871, 8/9/24

Amends the Public Higher Education Act. Provides that the governing board of each public institution of higher education shall adopt a policy to allow a student who is a member of the National Guard of any state, the District of Columbia, a commonwealth, or a territory of the United States or any reserve component of the Armed Forces of the United States to submit classwork and complete any other class assignments missed due to the student participating in a drill required as a member of the National Guard or the reserve component.

HR0506 - SUPPORT FAMILY CAREGIVERS Veteran Caregiver Benefits *Resolution Adopted 5/3/24*

Urges the passage of important policies to better support family caregivers, particularly by enacting policies that: (1) provide increased funding for Illinois' Community Care Program, Home Delivered Meals, the Illinois Family Caregiver Act, Illinois Area Agencies on Aging, Illinois Case Coordination Units, Long-Term and Home Care Ombudsman, and other older adult programs and resources for Illinois caregivers at the Illinois Department on Aging and other State agencies, and examine policy changes to improve the navigability of these resources, (2) improve the inclusion of family caregivers in their loved one's care and hospital discharge and planning, and provide them with the education, training, and support they need, including as their loved one moves from one place of care to another, in Hospital at Home programs, in Medicare more broadly, and in measures of provider engagement with and in support of family caregivers and family caregivers' experience of care and support, and support veterans and their caregivers, (3) increase access to options and eligibility for care at home, including but not limited to providing permanent financial protections for the spouses of individuals receiving Medicaid Home and Community Based Services, incentivizing Home and Community Based Services expansion, expanding caregiver and senior support options and resources in the State's

Community Care Program, and more, (4) attract and retain direct care workers through increased pay and benefits, improved training, career pathways, and other job improvement initiatives, and (5) provide financial relief for family caregivers, such as through a family caregiver income tax credit, to help offset a portion of caregiving expenses paid by caregivers.

SB2626 - CRIM ID ACT-EXPUNGEMENT FILING

- Expungement from Veterans Treatment Court

Became Public Act 103-0755, 8/2/24

Amends the Criminal Identification Act. Provides that, in anticipation of the successful completion of a diversion program, a petitioner may file a petition for expungement at least 61 days before the anticipated dismissal of the case. Provides that, if a petition is filed, and upon the successful completion of the diversion program and dismissal of the case, the court shall review the petition and shall grant expungement if the petitioner meets all requirements. Amends the Drug Court Treatment Act, the Veterans and Servicemembers Court Treatment Act, and the Mental Health Court Treatment Act to make conforming changes.

SB3479 - Claim Shark Amendment

Became Public Act 103-0783, 8/6/24

Amends provisions of the Consumer Fraud and Deceptive Business Practices Act concerning deceptive practices targeting veterans and military members. Changes the definition of "veteran or military benefits services" to any services offered or provided to a veteran, military member, or family member who is entitled to receive benefits under federal, State, or local law, policy, or practice as a result of, at least in part, qualifying military service. Such services include assistance, consulting or coaching in the preparation, presentation, or prosecution of claims or other attempts to obtain benefits, increase benefits, or appeal a decision related to obtaining or increasing benefits. Adds a veterans services disclosure to be made by any person providing veteran or military benefits services. Makes it an unlawful practice for any person providing veteran or military benefits services to fail at the outset of the business relationship to clearly provide, both orally and in writing, veterans services disclosures when veteran or military benefits services are provided in exchange for any financial compensation, benefit or thing of value. Makes other changes.

Legislation of the 103rd General Assembly that remains to be considered:

HB2239 - INTERNET GAMING ACT

Filed with the Clerk 2/8/23
4/5/24 Re-referred to the Rules Committee

Creates the Internet Gaming Act. Authorizes an Internet gaming operator to offer Internet gaming in accordance with the provisions of the Act. Provides that Internet gaming shall only be offered by an Internet gaming license or an Internet management services provider that has contracted with an Internet gaming licensee. Provides that an internet

gaming licensee shall offer no more than 3 individually branded Internet gaming skins. Provides that an Internet management services provider may conduct Internet gaming on its own Internet gaming platform pursuant to the agreement between the provider and an Internet gaming licensee and in accordance with the rules of the Board and the provisions of the Act. Includes provisions for: requirements of an Internet gaming platform; Internet waging accounts; license requirements; age verification, location, and responsible gaming; diversity goals in procurement and spending by Internet gaming licensees; acceptance of out-of-state wagers; and limitations on home rule units. Provides that a 15% privilege tax is imposed on Internet gaming to be deposited into the State Gaming Fund. Authorizes the adoption of emergency rules to implement the Act and makes conforming changes in the Illinois Administrative Procedure Act. Effective immediately. OPPOSE

HB4128 - VETERANS DAY-PAID LEAVE

Filed with the Clerk 8/23/23 4/5/24 Re-referred to the Rules Committee

Creates the Veterans Day Paid Leave Act. On and after January 1, 2025, requires each employer to provide each employee who is a veteran with a paid day off on Veterans Day if the employee would otherwise be required to work on that day. Provides that the employee must provide notice to the employer that he or she intends to take time off on Veterans Day and must provide the employer with documentation verifying that he or she is a veteran. Amends the Illinois Income Tax Act. Creates an income tax credit in an amount equal to 100% of the wages paid by the taxpayer to a veteran as a result of the paid day off required under the Veterans Day Paid Leave Act.

HB4187 - REPEAL ILLINOIS TRUST ACT Changes to Illinois ID Card Filed with the Clerk 10/23/24

10/25/24 Referred to Rules Committee

Repeals the Illinois TRUST Act. Makes corresponding changes in the Illinois Identification Card Act and the Illinois Vehicle Code.

HB4574 - CD CORR-AGGRAVATING FACTORS Crimes Against Veteran, aggravated circumstance Filed with the Clerk 1/24/24 1/31/24 Referred to Rules Committee

Amends the Unified Code of Corrections. Provides that if the defendant committed the offense in or on the grounds of a hospital, ambulatory surgical treatment center, physician's office, or other medical facility that treats patients and the offense was a crime of violence committed against a licensed health care professional or an employee of a hospital, ambulatory surgical treatment center, physician's office, or other medical facility that treats patients, this factor shall be accorded weight in favor of imposing a term of imprisonment or may be considered by the court as a reason to impose a more severe sentence. The act already provides for acts against the elderly, members of the Armed Forces, veterans performing duties as a representative of a veterans' organization.

HB4599 - HOME MODIFICATION PROGRAM ACT

Filed with the Clerk 1/29/24 4/5/24 Re-referred to Rules Committee

Creates the Home Modification Program Act. Provides that the purpose of the Act is to establish a home modification funding system that is streamlined, effective, and administered by experts within the disability community. Provides that, subject to appropriation, the Department of Human Services shall establish a Home Modification Program to provide financial assistance to persons with disabilities for home modification projects. Requires the Department to designate a statewide association that represents centers for independent living to serve as the lead agency to administer the program. Requires the Department to provide funding for the Program. Requires the lead agency to distribute any moneys it receives from the Department to the State's 22 centers for independent living, covering all 102 counties. Provides that the lead agency shall ensure that each center for independent living has access to at least \$105,000 to use for home modification projects, with the excess funds subject to reallocation during the 4th fiscal quarter of each year. Contains provisions concerning eligibility requirements for applicants under the Program; the lead agency's establishment of a Home Modification Subcommittee to provide additional oversight of the home modification projects; and an administrative fee to the lead agency.

HB4677 - CAREGIVER ASSISTANCE RESOURCES

Filed with the Clerk 2/1/24 4/19/24 Passed House 4/24/24 Arrive in Senate 5/17/24 Re-referred to Assignments

Creates the Illinois Caregiver Assistance and Resource Portal Act. Requires the Department on Aging, in consultation with the Department of Healthcare and Family Services, the Department of Public Health, and the Department of Veterans' Affairs, to be responsible for the creation and maintenance of the Illinois Caregiver Assistance and Resource Portal (Portal). Provides that the Portal shall serve as a centralized and trusted online platform offering a wide range of resources related to caregiving, including, but not limited to: (1) information on State and federal programs, benefits, and resources on caregiving, long-term care, and at-home care for Illinois residents who are 50 years of age or older; (2) educational materials, articles, and videos on caregiving best practices; and (3) accommodations for users with different language preferences, ensuring the information is accessible to diverse audiences. Sets forth additional resources and information that the Portal may feature, such as information on caregiving resources, home and community-based services that support family caregivers, nursing home care, services and programs offered by Area Agencies on Aging, relevant health care and financial assistance programs, and local support group opportunities for caregivers. Requires the Portal to be designed to be user-friendly and accessible to individuals of all ages and abilities and to include features such as search functionality, language accessibility, and compatibility with assistive technologies to ensure that a diverse range of caregivers can use it. Contains provisions concerning required outreach and promotional campaign efforts to raise awareness of the Portal, reporting requirements, and State and federal funding for the Portal. Requires the Portal to be implemented one year after the effective date of the Act.

House Committee Amendment No. 1 adopted 4/18/24

Provides that the Illinois Caregiver Assistance and Resource Portal shall be implemented 3 years (rather than one year) after the effective date of the Act.

House Committee Amendment No. 2 adopted 4/18/24

Makes the creation and establishment of the Illinois Caregiver Assistance and Resource Portal subject to appropriation.

HB4868 - VETS-IMMIGRATION SERVICES

Filed with Clerk 2/6/24 2/7/24 Referred to Rules Committee

Amends the Department of Veterans' Affairs Act. Establishes a military immigrant family legacy program within the Department of Veterans' Affairs. Requires the program to be jointly developed and implemented by the Director of Veterans' Affairs (Director) and the Adjutant General of the Department of Military Affairs, in consultation with the Department of Human Services' Office of Welcoming Centers for Refugee and Immigrant Services. Provides that the primary purpose of the program shall be to assist uniformed service members, veterans, reserve component members, and their family members to secure legal immigration status in the United States, including, but not limited to, citizenship. Provides that 2 military immigrant family legacy program coordinators shall be appointed to administer the program. Sets forth the coordinators' duties, including, but not limited to: (1) assisting intended recipients, who may qualify for adjustment of status, special immigration status through the federal Parole in Place program, or any other sort of immigration relief, including relief that can lead to citizenship: communicating with the Director and the Adjutant General and the Department of Human Services' Office of Welcoming Centers for Refugee and Immigrant Services regarding existing policies and regulations pertaining to the needs of intended recipients and to make recommendations regarding the improvement of benefits and services to such intended recipients; and (3) developing and maintaining a clearinghouse for information and resources relating to the program as well as other federal, State, local, and nonprofit programs that may offer assistance to intended recipients in immigration matters. Requires program coordinators to submit a report to the Director and the Adjutant General on January 1, 2026 and each January 1 thereafter that provides a description and evaluation of the coordinators' activities for the preceding calendar year as well as any recommendations for future programmatic changes. Requires the Director and the Adjutant General to jointly submit the report on an annual basis to the Governor and the General Assembly. Makes conforming changes to the Department of Human Services Act and the Military Code of Illinois.

HB5074 - MEDICAL RECORDS-COPY EXPENSE

Filed with Clerk 2/8/24 2/8/24 Referred to Rules Committee

Amends the Code of Civil Procedure. Prohibits a health care provider from charging a handling fee for providing medical records to a patient or patient's representative if they are electronic records retrieved from a scanning, digital imaging, electronic information, or other digital format in an electronic document. Repeals the annual adjustment for the handling fee for inflation.

HB5653 - VETERANS' SERVICES TASK FORCE

Filed with the Clerk 2//9/24 **Passed House on 4/17/24**Arrived in Senate 4/18/24

5/17/24 Re-referred to Assignments

Amends the Department of Veterans' Affairs Act. Reenacts a provision concerning the Veterans'

Service-Related Ailments Task Force repealed by Public Act 102-417. Changes the name of the Veterans' Service-Related Ailments Task Force to the Veterans' Services Task Force. Changes the frequency of Task Force meetings to at least twice a year and at any other times the Task Force deems necessary. Requires the Task Force to submit its report to the Governor and the General Assembly by December 31, 2025. Repeals the provisions creating the Task Force on December 31, 2026.

HB4680 VETERAN SERVICE ORGANIZATIONS

Introduced 2/1/24, in Rules Committee 2/6/24

Amends the Veteran Service Organizations State Charter Act. Changes the name of the Act to the Veteran Service Organizations Equal Act. Provides that a veteran service organization shall be considered to have veteran service organization status (rather than shall be considered state chartered). Requires a veteran service organization to have annual expenditures that demonstrate that 20% (rather than a majority) of the organization's expenses reflect support for veterans in order to qualify for veteran service organization status. OPPOSE

HFA #1 to SB 2315—Replaces everything after the enacting clause. Amends the Property Tax Code. In a Section granting a homestead exemption to veterans with disabilities, provides that property that is used as a qualified residence by a veteran who was a member of the United States Armed Forces during World War II is exempt from taxation regardless of the veteran's level of disability. Provides that a veteran who qualifies as a result of his or her service in World War II need not reapply for the exemption. Makes changes concerning service-connected disabilities. Makes changes concerning surviving spouses.

SB2665 - OMA-SERVICE MEMBER ATTENDANCE

Filed with Secretary 1/10/24 4/9/24 Passed Senate, arrived House 4/10/24 Referred to Rules Committee 5/31/24 Re-referred to Rules Committee

Amends the Open Meetings Act. Provides that, if a quorum of the members of the public body is physically present, a majority of the public body may allow a member of that body to attend the meeting by other means if the member is prevented from physically attending because of performance of active military duty as a service member. Defines "active military duty" and "service member".

SB2666 - MILITARY FUNERAL HONORS LEAVE

Filed with Secretary 1/10/24

6/26/24 Referred to Assignments

Amends the Family Military Leave Act. Changes the name of the Act to the "Military Leave Act". Provides that an employee may use up to 8 hours per calendar month to participate in a funeral honors detail, up to a total of 40 hours per calendar year, or more if authorized by the employer or if provided for in a collective bargaining agreement. Provides for requirements to take leave for funeral honors details. Provides that an employee that takes leave may do so in lieu of, and without having exhausted, his or her vacation leave, personal leave, compensatory leave, or any other leave that may be granted to the employee, including sick leave and disability leave. Defines terms. Provides that the employer of an employee that takes leave must pay the employee his or her regular rate of pay for the leave taken to participate in a funeral honors detail. Makes conforming changes.

SB2674 - PROCUREMENT-VETERAN PREF

Filed with Secretary 1/10/24 6/26/24 Referred to Assignments

Amends the Illinois Procurement Code. Provides that the certification of service-disabled veteranowned small businesses and veteran-owned small businesses is an exclusive power and function of the State. Denies home rule powers.

SB2700 - PROP-TX-DISABLED VETERAN

Filed with Secretary 1/10/24 5/3/24 Re-referred to Assignments

Amends the Property Tax Code. In provisions concerning the homestead exemption for veterans with disabilities, provides that the exemption applies to all real property that is the primary residence of a veteran with a disability (currently, property with an equalized assessed value of less than \$250,000 that is the primary residence of a veteran with a disability). Provides that, with respect to veterans with a service connected disability of 70% or more and surviving spouses of veterans whose deaths were service-connected, the first \$250,000 in equalized assessed value of the property is exempt.

SB2751 - LOCAL-DISABLED VET PERMIT FEE Home Improvement due to Disability **Became Public Act 103-0621, 7/1/24**

Amends the Counties Code, Township Code, and Illinois Municipal Code. Provides that a veteran with a disability or the veteran's caregiver shall not be charged any building permit fee for improvements to the residence of the veteran with a disability if the improvements are required to accommodate a disability of the veteran. Provides that the applications, forms, and other paperwork required to obtain a building permit must still be submitted. Limits the concurrent exercise of home rule powers. Effective January 1, 2025.

SB2950 - VETS-MENTAL HLTH CASE MANAGER

Filed with Secretary 1/31/24 5/3/24 Re-referred to Assignments

Amends the Department of Veterans' Affairs Act. Provides that a veterans case manager shall be appointed by the Director of Veterans' Affairs, in consultation with the Secretary of Financial and

Professional Regulation and the Secretary of Human Services, to assist veterans in obtaining the greatest degree of mental health care and mental health care benefits available and to promote policies that would benefit veterans seeking mental health care. Provides that the case manager shall serve at the pleasure of the Director of Veterans' Affairs. Sets forth the duties of the veterans case manager, including, to: (i) act as an intermediary between health care facilities and veterans health care facilities; (ii) provide information to veterans and health care facilities regarding mental health services available to veterans; (iii) apply for, receive, and administer federal aids, grants, and gifts relating to inpatient mental health services for veterans; (iv) encourage physicians, nurses, and other individuals working in mental health care who have military experience to work in Illinois; and (v) collaborate with health care facilities in identifying, upon a person's admission to a health care facility, the person's eligibility for federal veterans benefits, including prescription drug benefits. Amends the Hospital Licensing Act. Requires the Department of Financial and Professional Regulation to adopt rules requiring hospitals, upon identifying a person requiring mental health services as a veteran, to establish and implement certain protocols including (1) contacting the veterans case manager regarding the veteran's admission, (2) identifying whether the veteran is at risk for causing harm to the veteran's self or others, and (3) preventing the hospital from treating a veteran with less or different care than nonveteran patients solely because of a person's veteran status. Amends the Department of Professional Regulation Law. Requires the Department of Financial and Professional Regulation to establish rules requiring licensed health care professionals, as specified, to receive continuing education credits regarding the treatment of veterans as a condition of license renewal.

SB3074 - VEH CD-REG FEES-VETERANS-WAIVE

Filed with Secretary 2/2/24 2/2/24 Referred to Assignments

Amends the Illinois Vehicle Code. Provides that the standard registration fee for passenger motor vehicles of the first division and motor vehicles of the second division weighing not more than 8,000 pounds shall be waived for any veteran who holds proof from the United States Department of Veterans Affairs of a service-connected disability.

SB3417 - VETERANS COURT-PTSD-PROCEDURES

Filed with Secretary 2/8/24 2/8/24 Referred to Assignments

Amends the Veterans and Servicemembers Court Treatment Act. Provides that if a veteran with a service-connected disability is arrested for or charged with a criminal offense and there is prima facie evidence that the veteran was suffering from an episode of post-traumatic stress disorder or a related mental health condition during the commission of the offense, there is a rebuttable presumption that the veteran is eligible to participate in a veterans and servicemembers court program, and after the arrest or charge, the following procedures shall take place: (1) the veteran shall be evaluated and treated as soon as practicable by a qualified medical professional for post-traumatic stress disorder and any other mental health condition or disorder; and (2) the court shall order a screening and clinical needs assessment and risk assessment and a mental health and substance use disorder screening and assessment. Provides that if a veteran with a service-connected disability is charged for the first time with a criminal offense, including a felony, except certain offenses that would make him or her ineligible to participate in a veterans and servicemembers court program, and suffered from post-traumatic stress disorder or a related mental health condition during the commission of the offense,

then, upon successful completion of the terms and conditions of a court program, the court shall dismiss the original charges against the veteran or successfully terminate the veteran's sentence or otherwise discharge the veteran from any further proceedings against the participant in the original prosecution. Establishes certain procedures to be followed when a combat veteran who is a disabled veteran has an episode of post-traumatic syndrome disorder and needs assistance.

Department of Illinois Poppy Sales and Production Committee-HQ

September 28, 2024

The meeting was called to order by VC Todd Latham at 10:04 AM.

Unfinished Business-

Discussion occurred on volunteer help and poppy assembly in and outside of veteran's homes.

Division Poppy Seminars should be held to promote our programs, with the Legion and Auxiliary working together to inform, share, and clarify the poppy program.

VC Latham stressed the seminars are also used to distribute prepurchase and poppies for purchase to reduce shipping costs for post, units, and the Department.

The committee would like the Department to provide a list of posts that assembled poppies last year and any credit on file for use with the 24-25 program.

New Business-

The committee reviewed the current Poppy Post Contest Rules and Guidelines. No changes were noted.

The committee was informed that 110,000 poppies were produced and assembled. All equipment works correctly to complete orders. Currently, all equipment is working, and production is on schedule.

Commander Lamber, Sr. Vice Smith, and Adjutant Theilen entered at 10:34 am. The commander stressed that chairs and vice chairs are to make sure end-of-year reports arrive at the department on time. Sr. Vice spoke about the current membership status, and the Adjutant asked that the committee review the website and submit updates to C. Corsello.

Committee member Dudley asked how to improve constant contact to push information out to blue cappers. The adjutant and Membership should be requested to create a list.

They departed at 10:46 am when PNC Conatser arrived and updated the committee that the Department profited \$70,000 and a new \$6,000 machine was purchased to replace an outdated model. Our poppy cloth production went out of business, and enough material was purchased for output into the following year. The department is having an issue finding new clothing that is made of similar material and starch content. PNC Conatser estimated that 140,000 to 160,000 poppies are ready for sale to posts and units, and volunteers and the print room staff have been instrumental. No external assembly is needed at this time, as Manteno, LaSalle, and Danville veterans are assisting.

The committee continued with its unfinished business, reviewing the website for updates. All Division reps are submitting their Poppy Seminar dates. VC Latham agreed to share his training PowerPoint presentation with the rest of the committee to continue training.

Prayer was offered, and a salute to the colors concluded the meeting adjournment at 10:57 am.

Discussion and Recommendations:

Posts should have a Social Communications officer. They would cover social media, print, and news releases. At first this could simply be by appointment of the commander. Long term, posts should review their by-laws and add this officer and eliminate archaic or no longer used positions.

Encourage leadership at all levels to follow other Posts, Divisions, and Departments on Facebook. It is recognized that no social media platform has 100% reach. However, those that use Facebook can find that the exchange of information and ideas is straightforward.

Mylegion.org. is the data set of record. Members need to update their information. Department should use only the information held within Mylegion to update department directory. If the information is not correct, it is the member that needs to update it. It is recognized that some members still struggle with computers. Post leadership has the capacity to work with someone that can update their information for them.

Reach out to local papers to post news, any news the post may have

We recommend leadership looks at all programs but especially programs such as Orations. Orations were the Tik-Tok of the early 1900's. We have come a long way from that form of communicating insight and persuasion. We recommend the appropriate committee take this challenge and convert to a new contest asking for a video on the year's subject. You would be surprised at the creativity of youth. We ask how many times have you watched a reel or Tic-Tok video over and over and shared it? Now we ask how many times you have watch the full oration video and shared it?

Further, appropriate committee should look at the Scrapbook and Newsprint award. This also may be able to be better converted into post promotion video. The beauty of converting these two current competitions is that once you have the video, you may use them over and over again to promote the Legion or posts.

Have Department challenge each committee to make a video, 30 second to 1 minute, to make a video tiled 'This is What We Do'. We recognize that this is not applicable to many committees. However, there are many committees that have product and do great work. Make a short video of what you do and how it is fulfilling the one or more of the four pillars. How is our community involvement effecting veterans, youth, Americanism, and a strong defense? Tell our story.

What is the value of a committee if guidance isn't provided or expectations aren't presented.

Lastly, we discussed, and one committee member felt, it isn't well known that we are a nonprofit. It is important to stress that our organization is a nonprofit.

POW/MIA Report September 28, 2024

Our booth at Convention went well. We were a bit short of help due to several members health. Thanks to Chris Shoo and his wife of 5th Division for the help.

If you have stopped at our booth you have met Chella. Chella passed away Sept. 5. She was a Vietnam veteran serving as an air traffic controller. She was past Post, District, Division commander and past Chairman of the POW/MIA Committee.

Derrick Stinson of the 1st Division had a stroke several months ago and is doing well and gaining every day.

We gave out most of our T shirts as usual. The mesh back caps went well and we will be getting those again next year.

We also passed out information that showed the U S unaccounted for from Illinois in the Vietnam War. This information showed POWs, missing in action and killed in action/ bodies not recovered. This list is 65 total but from 2019.

I have a more current list from 2020 which is 47 unaccounted for.

Several committee members will be speaking at events this coming Veterans Day. I will be speaking at a combined Legion, VFW event in Chillicothe.

The third Friday in September is always POW/MIA Recognition Day.

Yesterday, Sept. 27th our committee had a meeting at Dept. headquarters.

So far in 2024 there have been a total of 122 returned for proper burial. From WWII 97, Korean War 22, Vietnam War 3.

Still missing from WWII 72,041, Korean War 7,464, Vietnam 3, Cold War 126.

Self-explanatory

Online 1,2,3 might consist of something like videos divided in the following way:

- 1. General Video [This would be like the general training at the seminar before the breakouts]
- 2. Officer Position Training [Each office position divided into three 20 min videos to be watched little by little or all at once; viewer's choice]
- 3. Basic Training [From the National Legion website]

In Person

These would be the trainings where we go throughout the state and train face to face as in the past. I'm hoping dividing our great state up might be something to look at so that folks don't have to go too far.

We usually had folks register at 8:30am, started seminar at 9am, lunch at 12pm then wrapped up around 2pm. How to get people to register will need to be decided and a registration. T Latham asked what about using Doodle to synchronize the committee members' availability prior to instruction dates.

The Chair could play with the timetable so that we don't start too early and don't get out too late for those driving furthest.

Some options could be:

- Time of Year training such as Spring & Fall at HQ
- Divide the state into 2 locations: Near Peoria & Vandalia [North & South]
- Divide the state into 3 locations: Near Streator, Springfield, Centralia [Straight down the center]
- Divide the state into 4 locations: Near Streator, Jacksonville, Mahomet, Centralia (Salem? /Mt Vernon?) [Diamond shape]
- Robbie Walker has access to the auditorium in Rantoul
- Or post with a large enough training area

After reviewing the proposed locations Div 1 and 2 committee reps felt northwest, northcentral and a northeastern location should be added and considered.

Some hurtles:

This idea presents some problems, of course. Here are some of the cons:

Online:

- How/to make videos.
- Our website is maintained very well, and we would have to rely on a 3rd party for postings and updates.

In Person:

- In the past we did seminars by request, and this was not effective outside of the 1st & 2nd divisions. So maybe we just offer as proposed above.
- In the past there weren't really any reimbursements beyond an occasional hotel room for those traveling several hours in the winter.
- Not sure how to work that budget or how you all feel about mileage and such.

Everything above is open for discussion, and the Chair asked members to get the manual together for the new year - January - for a good start!

Don Horn- 1st Division had a poor turnout at training. Bodies but busy with other Legion tasks, opportunities, the Div would want more training but closer to home in the 1st. District meeting would like it for new officers and procedures and unfamiliar roles/responsibilities. Last training in 1st was years ago with 80-100 but locations not easy to get to but have food and space. His thought was do it locally in Cook Co. and wait for the committee to meet. Individuals offered to teach but the 1st Div will do something.

Todd Latham proposed using the second half of the membership caravan to become an afternoon of training since they are membership training. Half day membership and speakers, half day legion leadership training. Would require Dept to preschedule and get registration done early.

My Legion in leadership manual is a need area for training.

How to capture data, fill out and use CPR.
