"STATE FAIR VETERANS' DAY AND UNIFORM GROUPS COMMITTEE shall publicize the Illinois State Fair Veterans' Day program throughout The American Legion, Department of Illinois; encourage each and every Post having an eligible unit to participate in the annual program. The duties and responsibilities of the Committee are to help on Veterans' Day at the Illinois State Fair. Members are assigned their duty by the superintendent of the fair. This Committee shall promote the organization, maintenance and sponsorship of the various types of musical and drill groups by the local Post, District, and County Council. They shall arrange for competitions, and prescribe the rules therefore, conforming to mandates of the National and Department Convention."

Veterans and Gold Star Day at the State Fair in Springfield for 2025 is August 16, 2026, and DuQuoin Aug 30, 2026.

The department budget has been the same for many years.

Miller reveiwed the organization of the State Fair Committee at IDVA. The only tasking the Legion has had was passing out pins to veteran visitors to the fair. Miller also acted as the parade organizer in 2025.

Food at the fair was catered. It was suggested by the IDVA committee that for 2026, volunteers from the various veteran groups be

available to assist in serving the meal, if a meal was to be served. For a few years, vouchers were distributed for food, but the money for that ran out. IDVA committee members were encouraged to find sponsors for meals at the fair.

Also discussed was soliciting businesses to made donations to the State Fair fund, to allow for better menu at the Veterans Lunch.

Miller suggested that department committee members attempt to determine if any posts have honor guard groups that may want to participate in competitions at the Department Convention. I know of the Joliet band, but don't know of others. Rules would be the same as those used at National competitions. Robert Zimbelman is on the department convention committee. There generally has been no competition and the convention committee has no funding for competition.

The Consolidated Veterans Assocation (CVA) has run the beer tents for the past several years. This is by contract with the Department of Agriculture. The CVA may or may not have the contract for the 2026 fair. CVA's contract sith the Dept of Agriculture is for a designated amount. If the beer tents "earn" more than the designated amount contracted for, the overage amount is shared with the posts the beer tent workers are from, based on hours worked. Posts are encouraged to sign up to staff a beer tent, generally, for the duration of the state fair. (2026 State Fair Dates Aug 13-23)

An in person meeting was called for the Department Legislative Commission at 10:00am on September 27, 2025. A zoom session was also active, which included American Legion Family members from the Auxiliary and the Sons of The American Legion.

Division 1 member Terry Cornell Jr was present via Zoom.

Chairman Miller opened the meeting with a salute to the colors and Pledge of Allegiance. Roll call and introductions followed.

Chairman Miller then read the purpose of Commission as found in the Department Directory:

"LEGISLATIVE COMMISSION shall accept resolutions requiring legislative action passed at the Department Convention, Cause Appropriate bills to be drawn in proper form by the Illinois Legislative Reference Bureau, and secure sponsors for such bills in both the Illinois House and Senate. Testimony before Legislative Commission will be presented by individuals indicated by the Legislative Commission Chairman and appropriate monthly reports will be made. Assistance will be given on Federal Legislation when requested by the National Legislative Director, or such other authorized person on the National level."

Miller suggested Division commission members need to pass information about legislative efforts down through the districts to the posts.

The commission was visited by Department Commander Roy Smith, Department Senior Vice Commander Celeste Latham, Department Adjutant Joshua Theilen, and Department Membership Mike Monroe.

Commander Smith provided a list of expectations for Committee Chairman and encouraged our commission in this election year, to emphasize the Legion "Get out the Vote" campaign. Adjutant Theilen provided a document regarding commission/committee Zoom meetings.

As there were no resolutions from the Department Convention that required action by the commission, Chairman Miller suggested our job in the commission should be to monitor and report on Legislation in Illinois affecting veterans or military members. We need to encourage Illinois

Legionnaires to become aware of and submit "Witness Slips" prior to hearings on legislation affecting veterans and military members. He encouraged everyone to create an account at the Illinois General Assembly website. (<a href="https://ILGA.gov">https://ILGA.gov</a>) This allows a person to create a list of bills they wish to follow in the 104th General Assembly and receive status of the bills. When hearing are scheduled, the status will give information about hearings and members then may submit Witness Slips to show they approve or disapprove the legislation. The ILGA.gov website has been revamped and what the witness slip process will look like will be forwarded once committee hearings are scheduled. A spreadsheet of bills affecting veterans was distributed to commission members and will be emailed to those not present in person.

A "Department Of Illinois TAL Legislative Action Center" group has been created on Facebook for use by commission members to get the word out regarding pending hearings and other actions on bills that have been introduced relating to veterans and military members. It is a private group and membership requests from commission members and district legislative contact will be approved to join the group.

Chairman Miller suggested visiting Springfield as a Legion Legislative Day, to visit members of the General Assembly and address the concerns of the Illinois American Legion, either Feb 4 or 18, 2026, ahead of the Veterans Legislative day tentatively scheduled for March 11, 2026. This would be strictly a voluntary effort as there is no funding to reimburse anyone for attending. Chairman Miller plans to attend a Department of Indiana Legislative Day scheduled for Monday, January 12, 2026 in Indianapolis, to get ideas for a possible Illinois Legislative Day.

At the National Convention, Legislative Chairman Matthew Shuman provided some training for Legislative visits to the capitol. In the training, two documents, "10 Tips for Successful Meetings on Capitol Hill" and a worksheet to plan your visit were distributed. The tip sheet and worksheets may be found at <a href="https://legion.org/advocacy/legislative">https://legion.org/advocacy/legislative</a> in the Advocacy Resources & Toolkit link. Scroll down to the "Downloadable Tools" on the right side of the page and download copies of the documents. These tips and worksheet are beneficial at all levels when planning a visit to an elected official.

Miller gave a quick review of the legislative pages on the national website to those attending the commission meeting. Our role in the National legislative arena is to help by promoting National programs and all members should sign up for the Grassroots newsletter and participate in the Voter Voice campaigns. The Grassroots newsletter has a scoreboard of Departments submitting Voter Voice emails to their elected officials. Illinois should be one of the top 5 in each newsletter.

Chairman Miller suggested that all members sign up for Fast Democracy, <a href="https://fastdemocracy.com">https://fastdemocracy.com</a>, a free service that tracks legislation on a national and state level and provides periodic email updates on actions being taken on bills. When signing up, select to receive emails on legislation affecting "Veterans and Military."

As there was no further business, the meeting was adjourned at 11:03am.

## **Boys State Committee**

The Fall meeting was called to order at 1000 hrs. on September 20th, 2025 by Chairman Benigno.

Role call was read and a quorum was present. There were no guests present.

The minutes from the spring meeting were distributed and approved.

#### The Treasurer's Report:

Expenditures and donations were discussed. The treasure's report was approved as given. A question was posed from a previous citizen in writing regarding additional scholarship monies, and how he could receive those funds since he was awarded the most any citizen could receive. The board elected not to entertain the request. The board did however have conversations about entertaining the idea of donating to the high schools that the two Boys Nation recipients come from on a yearly basis and that money would come out of the general fund and operating budget. Discussion was had around updating the by-laws and adding a zoom meeting in between our fall and spring meetings to discuss matters to strengthen our program.

#### The Chairman's Report:

Christopher stated that the program is almost where it needs to be and just needs a little fine tuning to get it to where it's more beneficial to the boys and thanked the staff for their commitment and hard work. We are working on marketing and advertising partnerships to assist with the expenses every year. It is crucial that we utilize all our volunteers onsite or remote every year. We need to keep our staff involved. I would hate to see anybody just fall off when they're passionate about the program and they want to come back, but they just can't. The Illinois Counselors Conference is November 13th and 14th. We have paid our fee for a silver sponsorship, which means we get a table with power. We get an opportunity to be part of their social evening, we have our logo on every newsletter that goes out from the time that we signed up, which was two months ago, and every newsletter they sent out until the time that the event happens in November. Chairman Benigno asked for a motion to allow for \$3,000.00 to get merchandise needed for the event. The motion and second was made and the body approved. New recruiting cards are in development. We will be looking into creating our own convention booklet. Possible targeted mailing to the post/district/division chairs. The alumni association is growing and bringing in outside (previous citizens) engagement. We will be continuing with the golden tickets.

#### **Programming Reports:**

Updating citizens spreadsheets. Updating citizen registration email response. More constant emails to registered citizens and their parents. Increased social media. New promotional videos. Positive exit interview responses from the citizens. We spoke about fine tuning the registration form to better know the local post in their areas. We spoke about the constant struggles of posts not reaching out to their candidates immediately so that the boy knows that he is going and could make the arrangements. We spoke about different ways to vet our new staff members. We had conversations around the upcoming new contract with EIU, and the additional expenditures it may bring along with logistical changes. We spoke about adding content creators every year and converting the citizen manual to a digital-first format. We will be applying for a Google grant to assist with marketing and advertising. We spoke about our upcoming 50 year partnership with EIU. Everything went well with contests and awards.

#### **Director of Counselors Report:**

Staff had a great experience and stated that it may have been the best year they have had. The staff worked well together and overcame a lot of curveballs. Communication will be fine tuned. The hand written letters were all completed this year.

#### **Director of Education Report:**

Seminars will be looked at and some may be revamped. There was one issue with a new staff member going off script. That was handled immediately during the session.

#### **New Business:**

Presentation of a resolution by Don Smolinski regarding adding a color guard scholarship in the amount of \$2,000.00 annually which will become the Huntley American Legion Post 673 Militia Scholarship to be funded by Post 673. The board of directors added that the recipient of this award will also be given an interview for Boys Nation. There was a motion and second and the motion was approved. John Garris from the 10th District and a staff member brought up some ideas to add to the program and the board is taking those into consideration. Sept. 27, 2025

The POW/MIA committee met at Department on September 27, 2025, at 1:00. Members present were John Buhle 1<sup>st</sup> Division 8<sup>th</sup> District, Paul Ahern 2<sup>nd</sup> Division 10<sup>th</sup> District, Sam Rice 3<sup>rd</sup> Division 16<sup>th</sup> District, Theresa Thomas 4<sup>th</sup> Division 17<sup>th</sup> District, Chris Schoo 5<sup>th</sup> Division 24<sup>th</sup> District.

When we got to our meeting we were informed that our members from the  $1^{st}$  Division and  $2^{nd}$  Division had been replaced. We introduced ourselves to the new members and explained what our committee's mission is.

Theresa, Chris and Sam spent quite a lot of time answering their questions.

Our mission is to promote public awareness to Legionnaires and the general public that the American solders that are still listed as mission are not forgotten.

We gave suggestions to John and Paul on how we speak at public events, especially near Memorial Day and Veterans Day, and National POW/MIA Recognition Day to make people aware of the MIA situations.

We also give reports at District and Division meetings.

We discussed our booth at the 2025 convention. Sam informed all that he would not be at the 2026 convention to man the booth.

We talked about who will get Sam's POW/MIA table to convention and set it up in front of the stage.

We also discussed how the booth went with only one table length in front. It was decided we would stay with one table frontage.

We were visited by Commander Roy Smith, Sr. Vice Celeste Latham, Adjutant Josh Thielen, and Membership Director Mike Monroe. Adjutant Josh gave us directions on guidelines of the committee chairman expectations and video conference guidelines. They also volunteered their help if needed.

This fiscal year of 2025, which just ended, the Defense POW/MIA Accounting Agency announced that 231 former MIAs were returned to their families for proper burial. Still

unaccounted for from WWII – 71,850; Korean War- 7,398; Vietnam – 1,566; Cold War – 126 for a total of 80,940.

Over 41,00 of those still missing are presumed lost at sea and may never be accounted for.

The meeting adjourned at 2:30 p.m.

# Department of Illinois DRC Ad Hoc October 4<sup>th</sup>, 2025, Committee Meeting Minutes

**Attendees:** Wayne Fischer 2<sup>nd</sup> Div. Chairman; Larry Hippert 1<sup>st</sup> Div.; Wayne Erickson 3<sup>rd</sup> Div.; Don Horn 1<sup>st</sup> Div. Commander; Marty Conatser Past Dept. Adjutant.

Task: Consolidate the 1st Division from 7 Districts to 4 Districts

Don Horn updated the Group on current status of this consolidation of Districts. The 1<sup>st</sup> Division District Commanders met this past August, and the consensus was to move forward on Redistricting the 1<sup>st</sup> Division as follows: 2nd and 3<sup>rd</sup> into the 2<sup>nd</sup> District; 4<sup>th</sup> and 5<sup>th</sup> District into the 3<sup>rd</sup>; 7<sup>th</sup> and 9<sup>th</sup> into the 1<sup>st</sup> District; and the 8<sup>th</sup> into the 4<sup>th</sup> District.

Boundaries have been tentatively drawn but may be subject to change prior to the final approval. There is more discussion coming out of the 2<sup>nd</sup> District and it will need to be covered to ensure what is needed will come together by our Spring DEC for final approval at our 2026 State Convention. Marty will be assisting on that.

As part of this, there are Posts that may want to remain in a District outside a designated District, which has happened before and worked okay. This could be more last minute decisions.

Don also included a preliminary 1<sup>st</sup> Division Redistricting Resolution-Phase 1 that has been reviewed by the District Officers. (see attached)

# 1st DIVISION REDISTRICTING RESOLUTION PHASE I

WHEREAS, The 1st Division is currently made up of Cook County; and

**WHEREAS,** Currently, the 1st Division has within its' boarders seven Districts consisting of Districts 2, 3, 4, 5, 7, 8, 9; and

**WHEREAS,** The 1st Division membership has been reducing over the years to where District mergers have been considered; and

**WHEREAS,** It is geographically logical to combine Districts 2 & 3, Districts 4 & 5, Districts 7 & 9: and

**WHEREAS,** The 8th District covers the bottom 20% of the Division and bound by County Boundaries on three of its four sides therefore it is advantageous to stand alone; and

**WHEREAS,** Separate agreements of each individual merger will be submitted with this resolution; and

**WHEREAS,** A follow-up resolution will be submitted with further details on the renaming of Districts, recommended boundaries and other warranted details; therefore be it

**RESOLVED,** The Redistricting of the 1st Division be made at the Departments earliest convivence and at one time in unison if possible to save the Department and her Division and Districts unnecessary time and expense; and therefore be it finally

**RESOLVED,** By The American Legion, Department of Illinois, at the Annual Spring Meeting, assembled in Bloomington, Illinois, April 11, 2026, that The American Legion, Department of Illinois approves the 1st Division recommendations of Redistricting.

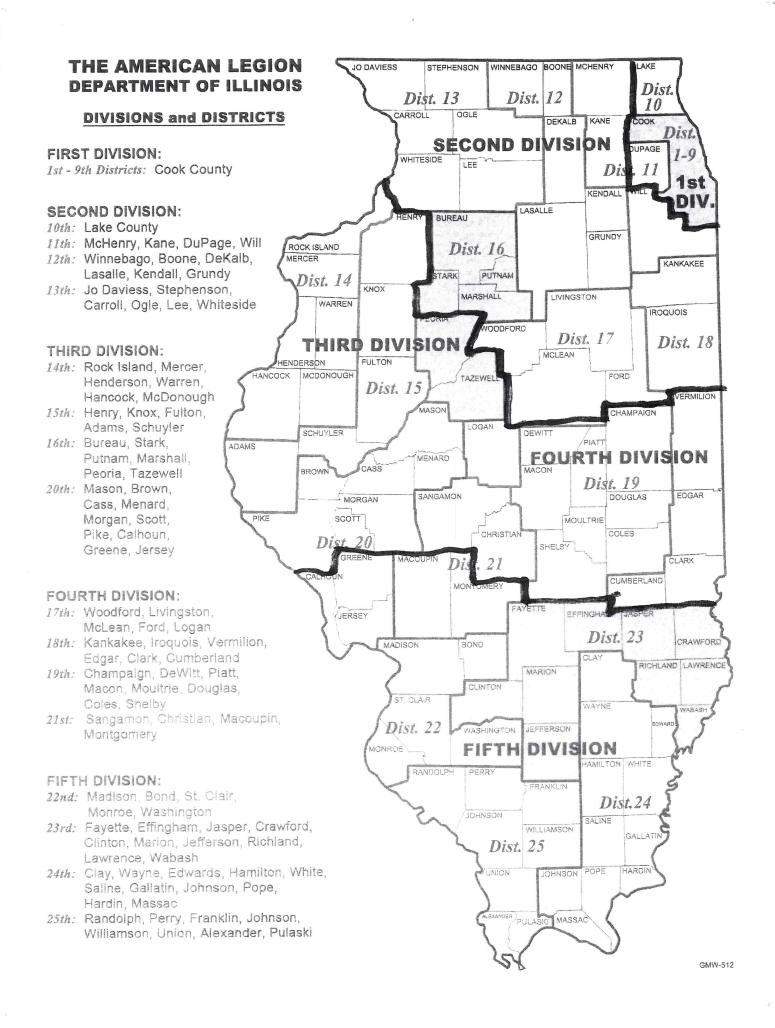
### **Moving Forward:**

# **Department of Illinois Internal Affairs Commission**

Minutes of Commission meeting held on: Saturday, September 27<sup>th</sup>, 2025 at

Chairman, Al Coughlin, opened the meeting at 10:15 AM.

The Internal Affairs Commission convened at 10:15 on Saturday, September 27th, 2025. The Meeting occurred at Department HQ in Bloomington, IL. Chairman Al Coughlin, 1st Division, attended and presided over the meeting. Members Tom Marcisniak, 2nd Division; Vice-Chairman Wayne Erickson, 3rd Division; Iris Miranda-Kirschner, 4th Division; were in attendance. Department Commander Roy Smith, 5th Division, attended was meeting with all other committees and attended our meeting later.

The meeting was convened with a quorum.

Department Commander Smith, Department Senior Vice-Commander Latham, and Department Adjutant Theilen, and Membership Director Monroe spoke about the status of Department changes, including the updates on the Department website.
